1 At the locations indicated, amend the bill as follows:

2 1. Page 4, line 4: delete lines 4 to 12 and substitute:

3 "59.23 (1) (a) Every clerk shall appoint in writing one or more deputies and file
4 the appointment in the clerk's office. The deputy or deputies shall aid in the
5 performance of the duties of the clerk under the clerk's direction, and in case of the
6 absence or disability of the clerk or of a vacancy in the clerk's office, unless another
7 is appointed therefor as provided in par. (c), shall perform all of the duties of the clerk
8 during the absence or until the vacancy is filled. The board may, at any meeting its
9 annual meeting or at any special meeting, provide a salary for the deputy or
10 deputies."
