<b>Description</b> Hunting, fishing, and trapping approvals issued to recipients of the purple heart medal					

### Assumptions Used in Arriving at Fiscal Estimate

Under current law, the Department of Natural Resources (DNR) must treat a qualified member of the armed forces, a reserve unit of the U.S. armed forces, or the national guard as a resident for purposes of determining the member's eligibility for, and cost of, obtaining hunting, trapping, or fishing approvals. Fees for approvals issued to residents are lower than for those issued to nonresidents. For example, the fee for a non-resident gun deer license is \$160 compared to a resident gun deer license of \$24 (difference of \$136). Similarly, the fee for a non-resident annual fishing license is \$50, compared to a resident annual fishing license of \$20 (difference of \$30). This bill expands this treatment to a non-resident who has received the Purple Heart medal.

Under current law, a conservation patron license confers a number of fishing, hunting, and trapping privileges and allows free vehicle admission to state parks and related areas, as well as a free subscription to the Wisconsin Natural Resources Magazine. The fee is currently \$165 for residents and \$600 for non-residents (or a greater amount at the applicant's option). Under this bill, DNR must issue a conservation patron license at a reduced fee of \$10 to a resident or \$161 to a non-resident (or a greater amount at the applicant's option) who has received a Purple Heart medal. The reduced fee license excludes the free magazine subscription.

#### Assumptions

According to the Department of Veterans Affairs, there are an estimated 1,800 Wisconsin residents that are Purple Heart recipients, while estimates on the number of Purple Heart recipients that reside in other states is not readily available.

#### State Fiscal Effect

The fiscal impact on revenues to the Fish and Wildlife Account is indeterminate. Revenues will increase to the extent that reduced fees will prompt medal recipients to become first-time buyers of hunting, trapping, fishing or patron licenses, while revenues will decrease to the extent that medal recipients currently holding a hunting, trapping, fishing or patron license will opt for a license at the reduced fee.

The Department estimates one-time programming costs of \$20,000-\$45,000 for the Automated License Issuance System (ALIS).
