**ASSEMBLY AMENDMENT 5,  
TO ASSEMBLY BILL 885**

February 18, 2016 - Offered by Representatives BROSTOFF, SINICKI and KESSLER.

- 1 At the locations indicated, amend the bill as follows:
- 2 **1.** Page 2, line 9: delete “shall” and substitute “may”.
- 3 **2.** Page 2, line 10: after “plans” insert “, subject to approval by affected  
4 department heads,”.
- 5 **3.** Page 2, line 10: delete “shall”.
- 6 **4.** Page 2, line 11: delete the material beginning with “The” and ending with  
7 “emergency.” on page 3, line 18.
- 8 **5.** Page 3, line 22: delete “required” and substitute “provided”.
- 9 **6.** Page 4, line 2: delete “shall” and substitute “shall may”.
- 10 **7.** Page 4, line 9: delete “shall” and substitute “may”.
- 11 **8.** Page 4, line 13: delete “required” and substitute “provided”.
- 12 **9.** Page 4, line 23: delete “shall” and substitute “may”.

1           **10.** Page 4, line 24: after “debt” insert “unless, as it relates to individual debts,  
2 after any fee charge by the state, the debt is at least \$50”.

3           **11.** Page 5, line 1: delete lines 1 and 2 and substitute “a county. The county  
4 may withdraw, in whole or in part, from an agreement under s. 71.93 (8) (b) 2. if any  
5 combination of 2 of the county comptroller, treasurer, and clerk of courts submits to  
6 the department of revenue a report requesting withdrawal if the report shows that  
7 an alternative program for debt collection would be more efficient, inexpensive, or  
8 cost-effective for the county. The county may withdraw from the agreement at any  
9 time with the county board’s approval. For purposes of this paragraph, the county  
10 may do all of the following:”.

11           **12.** Page 5, line 11: delete “shall” and substitute “may”.

12           **13.** Page 5, line 16: after “county” insert “department originally responsible  
13 for collecting the debt”.

14           **14.** Page 7, line 3: delete “shall” and substitute “may”.

15           **15.** Page 7, line 9: delete “shall” and substitute “may”.

16           **16.** Page 7, line 12: after “programs” insert “, except that if the county receives  
17 an amount of revenue in a fiscal year under subd. 2. that is less than \$1,000,000, the  
18 county may pay the local workforce development board only the lesser amount in  
19 that fiscal year”.

20           **17.** Page 7, line 14: delete “secretary of revenue” and substitute “unit of county  
21 government originally responsible for collecting the debt”.

22           **18.** Page 7, line 15: after “secretary” insert “of revenue”.
