We need an amendment drafted to AB 119 please. Apologies for not catch this right away!

We'd like the bill (AB 119) language to match the Administrative Code language as follows:

The rule – Wis. Admin. Code sec. Ins 6.11 (3)(a)(2) reads, "Failure to initiate **and** conclude a claims investigation with all reasonable dispatch."

The bill – Page 2, Line 7 – (b) No insurer may fail to initiate **or** conclude with due dispatch an investigation of a claim for repairs to a motor vehicle on the basis of whether the repairs will be made by a particular contractor or repair facility.
