

**An Act to amend 446.028 of the statutes; relating to: approved sponsors of continuing education for chiropractors, chiropractic technicians and chiropractic radiological technicians.**

**Analysis**

Current law lists specific organizations that are allowed to sponsor chiropractic continuing educational programs for license renewal.

This bill corrects a previous error in the removal of the American Chiropractic Association as an approved sponsor and adds the Chiropractic Society of Wisconsin, a state chiropractic association. This bill also lists the approved sponsors for chiropractic technician and chiropractic radiological technician continuing educational programs for license renewal.

---

*The people of the state of Wisconsin, represented in the senate and assembly, do enact as follows:*

**SECTION 1. 446.028 Continuing education approval; program sponsors.**

Each program sponsor of a continuing education program required to be completed by a chiropractor, a chiropractic technician, and a chiropractic radiological technician as a condition of license renewal shall submit the program to the examining board for approval. In this section, "program sponsor" means the Wisconsin Chiropractic Association, the Chiropractic Society of Wisconsin, the American Chiropractic Association, the International Chiropractors Association, a college of chiropractic approved by the examining board, and a college of medicine or osteopathy accredited by an accrediting body listed as nationally recognized by the secretary of the federal department of education. "Program sponsor" does not include an individual, organization, or institution of higher education approved under s. 46.03 (38) to provide instruction in the use of an automated external defibrillator.

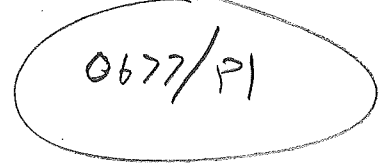
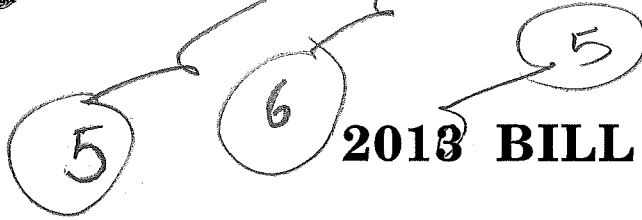

This bill specifies that a program sponsor for continuing education for certified chiropractic technicians and certified chiropractic radiological technicians must also submit its program to the board for approval.

Current law lists the program sponsors that may offer chiropractic continuing education programs acceptable for license renewal in this state. The bill adds the Chiropractic Society of Wisconsin and the American Chiropractic Association to that list.
