At the locations indicated, amend the bill as follows:

Page 2, line 6: after "holder." insert "For purposes of this subsection, the "operator or manager of the lunchroom" is the individual responsible for the administration of food services for a private school, charter school established under s. 118.40 (2r), tribal school as defined in s. 115.001 (15m), or school district. A private school, charter school established under s. 118.40 (2r), tribal school as defined in s. 115.001 (15m), or school district complies with the requirements of this subsection if the school or school district has one certificate holder.".
