John,

The statutes regulate hard ciders as wine. Thus, in order to manufacture hard cider, a person needs a winery permit. A winery permit is governed under s. 125.53 (1), Stats., which authorizes a winery to engage in the following activities:

- The manufacture and bottling of wine on the premises covered by the permit for sale to wholesalers holding a permit under s. 125.54.
- On the winery premises and without obtaining a rectifier's permit, possess intoxicating liquor and mix or blend intoxicating liquor to produce wine sold to wholesalers holding a permit under s. 125.54.
- Offer on the premises taste samples of wine manufactured on the premises to persons who have attained the legal drinking age.
- In addition to the winery permit, hold either one "Class A" liquor license or one "Class B" liquor license, but not both. The "Class A" liquor license or "Class B" liquor license may either be issued for the winery premises or for real estate owned or leased by the winery. If a "Class A" or "Class B" liquor license has also been issued to the winery, the winery may provide wine manufactured, mixed, or blended on the winery premises directly to the "Class A" or "Class B" premises and may offer the taste samples on the "Class A" or "Class B" premises.
- A winery holding a permit under this section may also make retail sales and provide taste samples on county or district fair fairgrounds as provided in s. 125.51 (10), but this wine sold at retail or provided as taste samples shall be purchased from a wholesaler holding a permit under s. 125.54.

As you can see from the bolded text above, an orchard producing hard cider may provide taste samples of the hard cider (wine) at its licensed premises, but only the hard cider manufactured on the premises (orchard). That being said, if the orchard wanted to provide taste samples of non-alcoholic cider from another orchard, it could do that as non-alcoholic cider is not considered a wine.

It is important to note that s. 125.04 (4), Stats., provides that a person does not need a license or permit to manufacture or sell "unadulterated apple cider." There is no definition of what constitutes "unadulterated apple cider." However, in

talking with DOR, it appears that they consider the fermenting process to be adulteration, thus making hard cider an adulterated cider.

To: Schmidt, Melissa Subject: hard Apple Cider Hi Melissa. I spoke with our constituent, Jim Lindemann of Cider House of Wisconsin, McFarland. They <u>do</u> hold a Wine permit. They are a bonded winery with the Alcohol and Tobacco Tax and Trade Bureau (TTB).

They have no other permits from Wis DOR. Fed requirements provide that for him to sell his cider on premise, he must produce it on premise. Which he does.

The alcohol content varies between 5% and 7%, depending on the product. They do not exceed the 7% limit.

Adulterated apple cider would be enhanced with something like ever-clear. They do not do that. They sell unadulterated hard apple cider.
