Ms Kuczenski,

Please prepare an amendment to SB73 to require an electronic backup to documents stored electronically. The purpose of the amendment is to reduce the chance that electronically stored documents will be lost if the register of deeds office experiences a cyber attack or other system malfunction that destroys electronically filed records. Most IT managers arrange for remote backup and storage of electronic records. The amendment is not meant to impose a requirement to backup the backup, but only to require a backup to the records stored electronically in the register of deeds office. The backup should be remote and segregated in such a way as to enhance survivability. Contact person in my office is Bridget Esser. Let her know if another drafter will be responsible for this request. SB73 is scheduled for executive action in committee this coming Thursday.

At the locations indicated, amend the bill as follows:

1. Page 4, line 8: after that line insert:

SECTION 3g. 59.43 (1) (w) of the statutes is created to read:

59.43 (1) (w) Remotely backup in an electronic format any filed or recorded document that is maintained by the register of deeds solely in an electronic format. Backup documents shall be stored remotely and segregated from the documents maintained by the register of deeds.”.
