Analysis by the Legislative Reference Bureau

This bill generally prohibits the Department of Corrections from establishing or enforcing a policy on overtime that results in the expenditure during the fiscal year of a greater amount of overtime compensation than was spent in the previous fiscal year.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

2 SECTION 1. 301.288 of the statutes is created to read:

3 **301.288 Policies regarding overtime.** The department may not establish

5 fiscal year of an amount of overtime compensation that is greater than the amount
6 of overtime compensation spent in the previous fiscal year, except as needed to make

1 adjustments for inflation or salary increases that were based on cost-of-living
2 increases.
