SENATE AMENDMENT, TO SENATE SUBSTITUTE AMENDMENT (TO SENATE BILL 239

At the locations indicated, amend the substitute amendment as follows:

1. Page 1, line 5: after "wells," insert "restricting who may draft permits issued by the Department of Natural Resources,".

2. Page 11, line 4 after that line insert:

"Section 5m. 299.06 of the statutes is created to read:

299.06 Applicant drafting prohibited. (1) Definitions. In this section:

(a) "Applicant" means a person who applies for an approval, modification of an

(b) "Approval" means a permit, license, certification, or approval that is issued, modified, or reissued under chs. 30 and 280 to 295.

approval, or reissuance of an approval.

1 (2) Drafting approvals. The department may not allow an applicant to draft any portion of an approval.".
