Could we have a companion amendment drafted to AB 460 and SB 322? This pertains to the notes in the technical amendment, specifically:

In order to exclude the above-described amounts in Wisconsin income, DOR suggests that the subtraction modification under s. 71.05(6)(b)53., Stats., should be expanded to include any amount recognized by an individual as income as a result of the state's payment of the individual's premium costs under s. 40.516(2), Stats.
