ASSEMBLY AMENDMENT 1,
SENATE
TO ASSEMBLY BILL 455 *374*

November 24, 2015 – Offered by Representative WEATHERSTON.

1 At the locations indicated, amend the bill as follows:

2 **1.** Page 1, line 4: delete “vehicles and” and substitute “vehicles, making an
3 appropriation, and”.

4 **2.** Page 4, line 23: after “department” insert “currently or”.

5 **3.** Page 6, line 2: after “department” insert “currently or”.

6 **4.** Page 6, line 16: after that line insert:

7 **“SECTION 9g. Nonstatutory provisions.**

8 (1) Notwithstanding section 16.42 (1) (e) of the statutes, if this subsection takes
9 effect in fiscal year 2016–17, in submitting information under section 16.42 of the
10 statutes for purposes of the 2017–19 biennial budget bill, the department of
11 transportation shall submit information concerning the appropriation under section
12 20.395 (5) (cq) of the statutes as though the increase in the dollar amount of that
13 appropriation by SECTION 9r (1) of this act had not been made.
