

TO ASSEMBLY BILL 455, 374

November 24, 2015 - Offered by Representative Weatherston.

At the locations indicated	, amend the l	bill as follows:
----------------------------	---------------	------------------

- Page 1, line 4: delete "vehicles and" and substitute "vehicles, making an
   appropriation, and".
  - 2. Page 4, line 23: after "department" insert "currently or".
  - **3.** Page 6, line 2: after "department" insert "currently or".
    - 4. Page 6, line 16: after that line insert:

### "Section 9g. Nonstatutory provisions.

(1) Notwithstanding section 16.42 (1) (e) of the statutes, if this subsection takes effect in fiscal year 2016–17, in submitting information under section 16.42 of the statutes for purposes of the 2017–19 biennial budget bill, the department of transportation shall submit information concerning the appropriation under section 20.395 (5) (cq) of the statutes as though the increase in the dollar amount of that appropriation by Section 9r (1) of this act had not been made.

SECTION	9r.	<b>Fiscal</b>	changes.

- (1) In the schedule under section 20.005 (3) of the statutes for the appropriation to the department of transportation under section 20.395 (5) (cq) of the statutes, as affected by the acts of 2015, the dollar amount is increased by \$118,700 for the fiscal year in which this subsection takes effect to increase funding for purposes related to the registration of certain vehicles that may display historical plates.".
  - **5.** Page 6, line 20: delete lines 20 to 22 and substitute:
- "Section 11. Effective dates. This act takes effect on the first day of the 12th month beginning after publication, except as follows:
  - (1) Section 9r (1) of this act takes effect on the day after publication.".
