Mr. Chairman and Members of the Subcommittee:

I am pleased to appear before you today to discuss the ease with which the public can obtain products that are marketed, designed, and sold to defraud urine drug use screening tests such as those administered in the Federal Workplace Drug Testing Program. [Footnote 1] For purposes of my testimony, I will refer to these products as masking products and will discuss ways in which some businesses peddle them on the Internet. Masking products fall into one of four categories: (1) dilution substances that are added to a urine specimen at the time it is collected or are ingested before an individual submits a urine specimen; (2) cleansing substances that detoxify or cleanse the urine

and are ingested prior to the time that an individual submits a urine specimen; (3) adulterants that are used to destroy or alter the chemical make-up of drugs and are added to a urine specimen at the time that it is provided for testing; and (4) synthetic or drug-free urine that is substituted in place of an individual's specimen and provided for testing. My testimony today summarizes our findings.

We began our work by searching the Internet to obtain an overview of the array of products available to mask drug use and located several Web sites that tout products that are used to mask the presence of illegal drugs when a urine drug test is administered. Then one of our agents, posing as a federal employee in a sensitive position who uses marijuana and cocaine and was looking for products that would allow him to pass an impending drug test, placed telephone calls to businesses we identified in our Internet search and purchased drug masking products from them. Through our Internet search, we also identified and visited a retail store in the Washington, D.C. metropolitan area that sells these products. Additionally, we interviewed officials at the Substance Abuse and Mental Health Services Administration (SAMSHA) of the Department of Health and Human Services (HHS) to obtain information on the operation of the Federal Drug Testing Program and the types of products or methods that are used by individuals to deceive drug tests. Finally, we obtained information from the Department of Justice (DOJ) and the Drug Enforcement Agency (DEA) and about federal laws relating to the sale of masking products and researched state laws on this issue. We conducted our investigation from August 2004 through March 2005 in accordance with quality standards for investigations set forth by the President's Council on Integrity and Efficiency. We are referring the results of our investigation to appropriate law enforcement authorities and thus are not naming the sources from which our purchases were made.

In summary, we found that products to defraud drug tests are easily obtained. They are brazenly marketed on Web sites by vendors who boast of periodically reformulating their products so that they will not be detected in the drug test process. In addition to an array of products designed to dilute, cleanse, or substitute urine specimens submitted to testers by drug users, approximately 400 different products are available to adulterate urine samples. The sheer number of these products, and the ease with which they are marketed and distributed through the Internet, present formidable obstacles to the integrity of the drug testing process.

The sales representatives of the businesses we contacted assured our investigator that the products they sold would enable him to pass an impending drug test despite his purported use of marijuana and cocaine. While all of the businesses offered products designed to defraud drug tests, the sales representatives recommended different types of masking products based on how frequently our investigator purportedly used drugs, whether he was subjected to drug tests that are announced or conducted randomly, and whether testing administrators closely monitored the collection of urine specimens. When our investigator said that he occasionally used marijuana and cocaine, the representatives recommended he purchase herbal supplements and minerals to be taken orally prior to the drug test. According to the sales representatives, these products act as cleansers or detoxifiers. When our investigator reported that he used marijuana and cocaine on a daily basis and that he was subjected to random drug tests, they recommended that, if he would not be closely monitored when he provided a specimen, he purchase synthetic urine or adulterants that are added to a urine specimen. The prices of the products that the sales representatives recommended.

ranged from about \$30 to \$79.

Currently, there are a variety of laws related to the sale of drug masking products. Under federal law, if such products are determined to be "drug paraphernalia," an individual may be prosecuted for selling them pursuant to 21 U.S.C. § 863.[Footnote 2] However, we have not found any reported federal cases in which individuals have been prosecuted for such sales. In contrast, some states specifically prohibit the manufacture, marketing, or distribution of drug masking products. For example, New Jersey, Florida, and Kentucky broadly outlaw the sale of any product designed to defraud or falsify a drug screening test.[Footnote 3] In some states, such as Louisiana and Texas, it is illegal for an individual to knowingly or intentionally deliver or manufacture substances designed to falsify or alter drug test results.[Footnote 4] Additionally, at least nine other states (Arkansas, Illinois, Maryland, Nebraska, North Carolina, Oklahoma, Pennsylvania, South Carolina and Virginia)[Footnote 5] have outlawed the sale of urine or adulterants for the purpose of passing drug tests. Of the nine states, only one--South Carolina--has prosecuted at least two individuals for marketing and selling masking products: one who sold urine substitution kits over the Internet[Footnote 6] and another who advertised that his store carried products that are used to pass drug tests by cleansing the system. [Footnote 7] Also, of the nine states, Illinois and Kentucky have made the offense punishable as a felony; South Carolina and North Carolina have made a second offense punishable as a felony; and it is a misdemeanor offense in the remaining states.

Background:

Pursuant to Executive Order 12564, dated September 15, 1986, the federal government established the Federal Workplace Drug Testing Program. It is administered by SAMHSA for the purpose of preventing and deterring the use of illicit drugs in the federal workplace, and to ensure that as the federal government maintains employee productivity. In 2004, SAMHSA revised the Mandatory Guidelines for Federal Workplace Drug Testing Programs to require that specimen validity tests be conducted on all urine specimens collected. [Footnote 8] Noting that there has been a recent increase in the number of chemical adulterants that are marketed on the Internet and in certain magazines, SAMSHA officials stated that validity tests are intended to produce accurate, reliable, and correctly interpreted test results and to decrease or eliminate opportunities to defeat drug tests. According to SAMHSA, approximately 400 different products are available to adulterate urine samples, and companies that market masking substances periodically offer new formulations of their products to avoid detection.

Internet Businesses Tout Success of Masking Products:

To determine how businesses market drug masking products on the Internet, our investigator conducted an Internet search using the words "pass drug test." He quickly found many Web sites that brazenly tout products and related information that enable users of illegal drugs to pass drug tests. For example, one Web site claimed that "passing a urine drug test has never been easier," while another boasts that it offers a "variety of detox products [that] will beat the drug test or you'll get 200% of your purchase price back." Yet another site advises prospective customers that its product formulas change approximately every 6 to 9 months to stay ahead of new validity tests performed by drug testing laboratories. These Web sites offer a full array of drug masking products.

Additionally, our investigator found some Web sites that provide an interactive format for prospective customers to find out which products best meet their individual needs. For example, one Web site provides a question and answer format for prospective customers and then recommends certain products based on the responses. Among these questions were:

How many times per week do you smoke or take other substances?

Are you watched when providing the sample?

Will you have at least an hour to prepare?

Are you taking a Department of Transportation regulated test?

After a purchaser clicks on the most appropriate responses to these questions, the site presents pictures and descriptions of recommended products that are available for purchase. This Web site offers a "one-price-fits-all" approach and charges \$32 for each of its products. It also provides a store locator that helps prospective customers find out whether retail stores in their local area carry these products.

To further investigate how these businesses market drug masking products, our investigator placed telephone calls to some of them. Posing as a federal employee looking for ways to hide his purported cocaine and marijuana use in an impending drug test, our agent asked the sales representatives for each of these vendors for information on products that would enable him to pass a drug test. While each vendor offered a number of products, most of the sales representatives tailored the particular type of masking product they recommended to information they elicited from the investigator about his purported drug use. They asked, for example, how often he used drugs and when he had most recently used them. They also asked about testing procedures, such as whether tests are conducted randomly or are announced in advance, and whether individuals providing urine samples are closely monitored.

When our agent described himself as a casual cocaine and marijuana user who undergoes announced drug tests, sales representatives recommended that he purchase cleansing products that are ingested orally prior to the test. According to the vendors, these substances detoxify or cleanse the urine if taken before a test is conducted. For example, one of the sales representatives said to our investigator, "if you can stay clean for at least two days, we have a detox drink that you would drink on the day of the test. It will keep you clean for five hours." For \$35,[Footnote 9] our investigator purchased the "detox drink." After telling another sales representative that he had used cocaine during the past week and had a drug test scheduled the following week, the representative told him "... the good news is we have a detox program. ... It's a four day program, and basically if you do that, you'll be OK for the test." For \$79, our investigator purchased the "detox program," which came with a urine test kit that a buyer can use at home to conduct a pre-test before submitting a specimen for a drug test.

When our investigator told the sales representatives that he uses cocaine and marijuana on a daily basis and undergoes random drug testing, they recommended that he purchase either synthetic urine or adulterant products. Recommending a synthetic urine product, a representative told our investigator, "you won't have to be as careful with our product. But you can still get away with it and people do get

away with it." Our investigator purchased the product for \$32. Another representative told our investigator that his company sells synthetic urine and that it is "better suited for random situations because the urine is premixed in the bag, sealed off, and irradiated so that it won't go bad." Our investigator paid \$49.95 for this product.

At the suggestion of two other sales representatives, our investigator placed orders for two adulterants. For \$29.95, he purchased one adulterant that is designed for people who use drugs daily and are subject to random drug testing. This product consists of two small vials containing liquids that are added directly to the urine specimen before it is submitted for drug testing. Additionally, he spent \$32 for another adulterant that is designed to be used at the drug test location. This product is a bag that contains two chemicals: one chemical is supposed to destroy the drug toxins and another purports to destroy traces of the first chemical. According to the product instructions, a urine specimen should be poured into the bag, mixed with the chemicals, and then poured into the specimen cup.

Using the store locator function on one of the Web sites, we identified a store in the Washington, D.C. area that sells drug masking products. Posing as someone needing information on products that would ensure passing an impending drug test, we visited the store and observed a variety of masking products displayed for sale. The owner of the store told us that he has sold masking products for the past 11 years, and that on some days he sells up to 4 detox products. Additionally, he told us that he has repeat customers. For one of his customers, he special orders certain products. While the store also carries synthetic urine, the owner advised us that the detox drinks are more popular and sell better.

Laws Regarding the Sale of Drug Masking Products Vary:

Under federal law, it may be illegal to sell drug masking products if the products are determined to be "drug paraphernalia." Specifically, under federal law, it is unlawful for any person to sell drug paraphernalia, which is defined as any equipment, product, or material... primarily intended or designed for use in ... concealing ... a controlled substance. [Footnote 10] The following factors may be taken into consideration in determining whether an item constitutes drug paraphernalia, including the instructions provided with the item concerning its use; descriptive materials accompanying the item which explain or depict its use; national or local advertising concerning its use; the manner in which the item is displayed for sale; and the existence and scope of legitimate uses of the item.[Footnote 11] However, officials from DOJ and DEA advised us that there have not been any federal cases in which an individual has been prosecuted for selling drug masking products under this statute and our independent research of federal case law databases did not find any.

In contrast, some states have statutes that specifically prohibit the manufacture or distribution of drug masking products. For example, a New Jersey statute specifically prohibits individuals from manufacturing, selling, or giving "... any instrument, tool, device, or substance adapted, designed or commonly used to defraud the administration of a drug test."[Footnote 12] Under the New Jersey statute, a person may be prosecuted if he or she submits a substance that purports to be from a person other than its actual source or otherwise engages in conduct intended to produce a false or misleading outcome of a drug test.[Footnote 13] Similarly, in Florida and Kentucky, it is illegal to manufacture, market, or distribute products

intended to defraud any lawfully administered urine test designed to detect the presence of controlled substances. [Footnote 14] In some states, such as Louisiana and Texas, it is illegal for an individual to knowingly or intentionally deliver or manufacture substances designed to falsify or alter drug test results. [Footnote 15]

In some other states, laws relating to drug masking practices are narrower. For example, in Nebraska it is illegal to provide bodily fluids for the purpose of altering the results of tests to determine the presence of drugs. In some states, such as Pennsylvania and Virginia, it is illegal to sell drug-free urine, but there is no specific prohibition on the sale of adulterants. In contrast, in some states such as South Carolina, Arkansas, North Carolina, Oklahoma, Illinois, and Maryland, it is illegal to sell urine or adulterants. However, of these states, only Illinois and Oklahoma prohibit the sale of synthetic urine.

In our research of reported cases we found two cases in South Carolina in which individuals have been prosecuted for the sale of masking products. In one case that was decided in August 2002, the South Carolina Supreme Court upheld a conviction for violation of a statute that prohibits the possession of adulterants intended to defraud a drug test. In that case, the vendor placed an advertisement in a magazine for a novelty store he owned which read: "Taking a drug test? Want to cleanse your system? We carry Readi-Clean, Carbo-Clean Plus, Quick Tabs, One Hour, Zydot, One Hour Klear, Body Flush." An undercover agent purchased an adulterant Zydot after the store clerk assured him that the product would allow him to pass a drug test for marijuana. In upholding the conviction, the Court relied on, among other things, the advertisement the defendant placed rather than a determination whether the product effectively masks drug use. [Footnote 16] Additionally, the South Carolina Supreme Court upheld the conviction of another vendor who sold urine substitution kits on the Internet.[Footnote 17] Included on the defendant's Web site were claims that, "Our Complete Urine Test Substitution Kits allow anyone, regardless of substance intake, to pass any urinalysis within minutes."



Fake urine poses law enforcement challenge

People trying to pass off another person's urine has long been an issue for Tippecanoe County, Ind., courts. In recent years, testers are seeing more synthetic urine kits. The (Lafayette, Ind.) Journal & Courier

LAFAYETTE, Ind. - For offenders who are unwilling to stay off drugs while serving time (/article/20130707/NEWS03/307070018/Fake-urine-poses-law-enforcement-challenge?gcheck=1)through community corrections or on probation, sometimes desperate times call for desperate measures, as the saying

For years, offenders have attempted to pass mandatory urine screens by borrowing "clean" urine from acquaintances.

But now, with increasing frequency, they're turning to synthetic urine blends that boast 0 percent failure rates and claim to contain the same characteristics as the real thing.

"People have been cheating, trying to cheat, for years — for as long as I've been doing this job," said Allison Miner, deputy director of Tippecanoe County Community Corrections. "What we're starting to see more of is the fake urine that people buy online and at head shops."

Miner and other testers in the Lafayette area have a message for those who think they can get away with it: They're onto you.

Most recently, on June 4, a West Lafayette woman was caught at community corrections with a device containing fake urine.

"We saw the tube sticking out," Miner said. "Officers followed the tube and found that it was taped to her."

And what offenders may not realize is that simply possessing synthetic urine and attempting to fool screening tests are crimes in Indiana.

Indiana has two laws related to the issue, both of which passed in July 2005 without much fanfare. Since then, eight people have been charged in Tippecanoe County with possession of a device or substance to interfere with a screening test, a Class B misdemeanor, according to data provided by Clerk Christa Coffey.

Comes with warning

Before it became illegal in 2011 to sell or possess spice, K2 and other synthetic marijuana blends, the small packets — marketed as potpourri and incense — contained a warning that the substance was "not fit for human consumption."

Similarly, synthetic urine is commonly sold with a warning that states "Intended for lawful use only" or "Novelty synthetic urine substitution product."

For a "novelty" item, the instructions included with the kit are surprisingly detailed. Users are told how to warm the fake substance to a temperature that matches actual urine when excreted.

Some kits designed for men are even anatomically correct, according to Nick Bray with Sentinel Offender Services, a California-based company that has an office at Tippecanoe County Court Services.

Sentinel does testing for the county's probation department and for court services.

"That way, it could appear to be the real thing, but they look quite fake," Bray said. "Some of the other ways people try to sneak urine in is through pill bottles.

"Most of them, when they get caught, say they figure they would be caught, but they wanted to try it anyway."

He said most offenders are men; the issue typically comes up once a month.

Monitored closely

And they try despite urine screens that are closely monitored at Sentinel and community corrections.

"Here, they are watched. We go in with them. They have to take off all unnecessary clothing items — coats, jackets," Miner said. "They have to drop their pants all the way to the floor. There are mirrors all around them. They cannot wash their hands right after."

Community corrections requires urine screens at least twice a month.

Similar observations are done by Sentinel. People on probation are subject to random urine screens.

When someone is caught, the devices or substances are confiscated, and a report is filed with the offender's probation officer or prosecutor's office. That will then lead to prosecutors asking for a person's probation to be revoked, which could result in prison or community corrections time.

Prosecutor Pat Harrington said his office usually files probation violations in lieu of criminal charges, since proving a violation is more quickly achieved, compared to sending synthetic or someone else's urine to a laboratory for analysis.

Used by job seekers

The issue isn't unique to the criminal justice system.

Blackbird Clinical Services in Lafayette provides drug screens for area employers and anyone else who requests one — parents who want their children tested, for instance.

President Kimi Hathaway said they have people who try to pass off synthetic urine or someone else's urine on a weekly basis. Blackbird does not observe urine screens, but synthetic urine often is suspected in cases where the urine is too hot or too cold. Only urine between 90 and 100 degrees is a valid sample, she said.

"If it's out of temperature (range) that is reported as a refusal," Hathaway said. "When we're putting programs together for clients, we do advise them on how to handle failing screens.

"What we suggest is, if someone is carrying fake urine, that means they're trying to pass it off as their own. Why give that person a second chance?"

Work-Comp Management Services Inc. in Lafayette does drug screens for area employers, the Tippecanoe County branch of the Indiana Department-of Child Services and for school corporations in Tippecanoe, Carroll and White counties.

"People come in here knowing what they're coming here to do," office manager April Kaufman said, "so we don't see it too often."

Still, they run into the issue about once a month, she said. When that happens, protocol is to throw out the sample and retest.

Most of us feel profound and immediate effects after smoking or consuming marijuana.

When these subside, there will still be marijuana metabolites remaining. Chemical remnants and residue that are still inside your body.

These are called cannabinoids and are what <u>can be</u> <u>detected</u> in your blood, urine, hair, saliva and finger nails.

Drug tests screen for the dominant and psychoactive cannabinoid compound tetrahydrocannabinol (Delta-9-

<u>tetrahydrocannabinol</u>), more commonly known as THC, and its metabolites.

The THC molecule

THC-COOH is the main metabolite and is stored in fat cells of your body.

THC and its chemical residues are also the targets when detoxing from weed.

How Long Does Weed Stay in Your System?

Although stored to a degree in organs such as the heart, brain and liver, the fact that the metabolites of marijuana are mainly stored in fat cells is what allows them to be detected for so long after use, if no steps towards detoxing THC are taken.

This is also the reason detoxing from cannabis use is trickier and takes so much longer than say from heavier drugs such as cocaine, heroin, opium, LSD, MDMA/extacy, GHB.

As an interesting sidenote, marijuana is classed as a Schedule 1 drug just like extacy, heroin, LSD and GHB and thus considered just as heavy in the eyes of the law, with jail as a possible consequence!

It is however legal for recreational use in Washington, Alaska and Colorado, and as medical marijuana in nearly half of the states. Sadly, a preemployment drug test can punish you still!

How it really does compare to other drugs aside from duration in your system is up for debate however (Warning: this 3 minute debate might make you laugh)..

Marijuana VS. Crystal Meth - Funny but ...



When it comes to the duration marijuana remains in your body, one could argue that for most people this is irrelevant to passing your drug test. What matters is rather for how long the pot can give a positive test result.

THC and its metabolites, like most medicines, has a half life in the body (of 1 to 2 weeks) meaning that the concentration will get lower and lower but it won't be completely gone for a very, very long time. Most drug tests in the U.S. give a positive results if the concentration is above 50ng/mL, although some labs do use 20ng/mL as the cut-off point, which makes a pretty huge difference, allowing less than half the concentration compared to the most common test.

There is a big difference of accumulated toxins between chronic users and those having just smoked at a single occasion.


This study showed traces in a urine drug test after four weeks of abstinence from weed.

The general consensus is that it can remain detectable naturally from anywhere between a couple of days (single use) and up to several months (chronic heavy user) in your urine.

In your blood, traces generally remain for a few days tops, but <u>can stay for a week or longer</u> in chronic and heavy users. It gets stored in the fat cells and then released over time into the blood.

In your hair weed use can be detected from months back. A typical hair drug test for daily, chronic users goes three months back.

Your saliva generally holds detectable amounts of THC residue for 1 day but in some regular smokers for 3+ days.



Exactly how long detectable amounts of THC will stay in your system is impossible to say for certain however. It depends on several factors, such as:

- ▶ The time since you last smoked weed
- How frequently you smoke
- In what quantities
- ▶ The strength/potency of your weed and strain
- ▶ Your metabolism
- ▶ What you eat
- ▶ Your body fat percentage
- ▶ How much you exercise and sweat
- ▶ Your weed detoxification efforts

All of these individually can have a large impact on your marijuana detox duration.

You can probably see why it's hard to set a general marijuana cleanse timeline.

How Do Detoxification And Detox Remedies Work?

Detoxing from weed serves the purpose of flushing the body of THC and its detectable metabolites.



This speeds up the possible withdrawal period and also allows you to pass a drug test a lot sooner than if you were not actively trying to detox.

Common ways of action to aid the weed detox process have to do with increasing the amount of fluids you excrete through urinating and sweating. For example, many THC detox supplements have diuretic properties.

Many remedies also increase your metabolism to speed up your body's natural toxin clearing mechanisms.

Supplying your body with proper nutrition will also help it do what it's supposed to do more efficiently.

A word of caution however is that attempts at detoxing THC too rapidly can alter your urine sample in ways that can make it seem suspicious and unacceptably <u>diluted</u> or contaminated for a urine drug test while affecting its density, specific gravity and creatinine levels, in the end meaning you'll need to be tested again.

Additional measures may have to be taken to be on the safe side.

Another often overlooked way that rapid detox measures can aid in, although mainly for heavier users who are addicted and having trouble with detoxing weed or even tapering off, is by shortening the withdrawal period.

This is basically the period it takes the body while detoxing to get back into its normal balanced state. Speeding up the detox process will thus help achieve this state faster.

During this period some people experience physical, psychological and emotional symptoms. Weed acts as a numbing agent and when suddenly being without it facing reality and ones feelings can get rough at first.

Note however that *most people* when quitting weed only experience minor physical discomfort from which they quickly recover, if any discomfort at all.

A More or less common symptoms can include: insomnia and sleeplessness, depression or euphoria, vivid dreams and nightmares, night sweats, mood swings, anger and irritability, fear or anxiety, loss of the sense of humor, increased or decreased sex drive, loss of concentration, headaches, body odor, coughing up phlegm, loss of appetite, digestion problems and cramps, nausea and vomiting, tremors and shaking, dizziness, kidney pains, hormone changes, impotency, low immunity and chronic fatigue.

Natural Things You Can Do To Aid Your

Detoxification Process

Before we get into the fastest and most efficient methods that involve marijuana detox products, I'd like to list a few things you can start doing *right now* to greatly aid your body's natural marijuana detox capacity and hence make it faster overall.

You will notice that they all have to do with the processes mentioned above in some way, since that is how all detox works.

These are great if there is still some time until your drug test. If it is within a week or two (or longer if its a urine test and you're a regular smoker) you may want to use these only to complement your weed detox and focus more on the products mentioned later as to not take any unnecessary risks.

Eat the right foods

There are foods that will make your marijuana detox faster and smoother.

On the other hand:

There are also foods that will do the opposite and actually slow down your detox.

Since THC is fat soluble you'll want to avoid fatty foods like the plague since this fat can absorb the THC and give it new opportunities to re-enter your blood-stream and tissues.

through stools and help lessen reabsorption of it from inside the intestines (sorry, but that means no junk-food).

Legumes and whole grains are good for fiber. Fruits and vegetables in general are great for detoxing.

Consider foods that are rich in the vitamin niacin such as avocados, tuna and potatoes.

Niacin is a real "flushing-vitamin" and thus good when you want to clear your system.

Foods that have lots of electrolytes such as potassium, magnesium and vitamin C are helpful. Citrus and lemon juice comes to mind. Tomatoes, melons, bananas, leafy green veggies, herbal teas etc.

The classic cranberry juice, golden seal and even vinegar can also be of benefit, but only to detox over time. Don't trust the myths about these ones.

But enough about food:

Drink, Drink, Drink



Am I telling you to swap one drug for another here? Of course not!

I am however telling you that no detox can be effective if you don't drink enough.

Water is what our bodies use to aid in transporting and flushing things out. That includes toxins, which includes THC metabolites.

Without sufficient fluid there can be very little movement. And that's bad.

Did I mention the word drink? Drinking a lot is the best way to ensure that you're excreting as much fluids as possible in the form of urine and sweat. And with this fluid the stuff that you want to get rid of.

It also helps cleanse your kidneys.

What you drink isn't as important as it is that you stay hydrated in general. Water is awesome, but juices and other low-fat beverages will do the trick as well.

In general the more you drink the better, but this can be over-done as well. Just make sure you get the recommended eight glasses of water a day and then some.

Exercise

As mentioned earlier, increased excretion of fluids works wonders for detoxing.

Sweating is the best way of accomplishing this.

And exercising happens to be the best way of getting sweaty in this case.

This is due to the added benefits of increased metabolism (another factor in a successful THC cleanse) and burning fat tissue.

And THC resides in fat cells remember? So burning some fat will only do you good.

Ideally you combine cardio with strength training. Some swimming or running as well as some weight lifting and you're all set!
(Easier said than done I know..)

Warning: Don't exercise the same day you're taking a cannabis drug test, since exercise can temporarily increase your blood THC levels by releasing it from fat cells.



Move your ass, but not right before your test!

I already mentioned the best way to get the sweat running down you cheeks which is to work out. However, it also happens to be the one that requires the most work...

If you're a feeling a bit lazy like me sometimes, there are other means to sweat.

Visiting a sauna is a great way to aid perspiration. Doesn't take much effort on your part but you're guaranteed to sweat a lot!

Another somewhat season-dependent way is sunbathing. This only works if it's really hot outside of course. But when it does work, it works great.

Rest

A lot of your body's natural detoxification actually takes place while you are sleeping.

Proper rest also ties in with allowing your body to function optimally.

So get enough sleep, and try to relax. A stressed out body does not detox as efficiently as one that is relaxed.



Relax!

If you're having trouble remembering all of these, try to remember the word DEERS where the letters stand for Drink, Eat, Exercise, Rest and Sweat.

Here's how to get weed out of your system fast and pass your drug test

Obviously the best way of passing a drug test is actually being clean and sober, not smoking weed at all. But that's boring.

So, let's get in to the right way of detoxing marijuana. The way that I detox marijuana myself and which has helped countless of people test clean.

I do want to point out however that these are by no means the *only* ways that works. There are many ways you can beat a drug test.

However, these methods happen to be really consistent.

It's worth noting that I take passing drug tests very seriously and that some of the most

effective THC detox products are a bit expensive. But I guess it's all just a matter of perspective. As with most things, in the end you get what you pay for..

For example, is \$200 really that expensive when compared to getting a potential job or even losing your current one and jeopardizing your future career?

In my opinion, nope, it isn't.

First I'm going to list the THC detox products I use and always keep in personal stock (since I get tested on a regular basis).

If you're in a position where you know you can get random drug tests without much warning, or get tested regularly, I'd suggest you do the same and stock up on the necessary THC detox products.

Trust me, it can be *gold worth* not having to wait a few days on shipping when you learn you have to take a urine test in a week. Time is precious and you'll want to get started on your THC detox plan as soon as possible if you want to eliminate risk.

(This actually happened to one of my friends who followed my advice of having an extra THC detox stock at home. He had never had a surprise drug test and suddenly got a 3-days heads up about a THC urine test at work (he'd been smoking heavily that same day). Luckily he had what he needed for his marijuana detox already. He was a nervous wreck and almost kissed my shoes out of gratitude when he was informed he had passed without any problems.)

If you know the type of drug tests you'll need to take (urine is the most common) it gets a lot easier and less expensive to have your THC detox prepared in advance. I, however, don't have that luxury and get different types of tests.

Anyways, here it is:

List of the best detox products (I keep these in home stock no matter what):



<u>Toxin Rid</u> – My definitive go-to THC detox product for easily passing urine and blood drug tests.

If there's one product you should get for said tests, it's this one. Do the 10 day detox when possible and leave nothing to chance.

This is the main THC detox product I recommend to my friends and combined we have passed literally hundreds of tests by now,

mostly urine tests.

Note that this is not a same day THC detox and that it works best when you combine it with one (see Stinger and Qcarbo below) in order to be 100% certain of testing negative.

The 7- and 5-day options are decent as well, it all depends on how much you've been smoking. A nice little peak is that you can choose to get a free marijuana at home urine drug test kit with the order when ordering any of these Toxin Rid detoxification

programs.

It never hurts having one for your future upcoming tests ready at home since it's not a same day detox. You want to be able to start your detox as soon as you know you have a test upcoming and not waste time waiting on shipping.

That being said, <u>TestClear</u>, the company that sells Toxin Rid (I don't think it is sold in stores anywhere but I'm not entirely sure), having been around since 1995 know how much shipping time matters to their customers and do offer a very fast (and discrete) 1-day shipping option.

They also offer <u>live chat support</u>, if you click here and look below their menu to the right <u>on their website</u>. This can be very useful if you're uncertain of what the best options to pass your test are or have any urgent questions.

Toxin Rid actually cleanses your system, whereas same-day detox drinks work more by masking the toxins temporarily (this is why you get a few hours window to take your test after a detox drink). Thus the toxins are still inside you, which is one of the reasons relying entirely on a same-day detox drink gives such inconsistent results.

Combined, Toxin rid will leave you with a very small amount of THC left in your body (how little again depending on how much you've smoked) which can be easily masked with the detox drink.

There are other detox products that work over a number of days too (usually 7 or 10), but I've found most of them really lackluster in comparison to a 10-day Toxin Rid course.



Qcarbo32 or Stinger – The go-to same day marijuana detox drinks for urine drug tests . You can choose either one.

They are among the most popular and well-documented brands of weed detox drinks used among people over the net



Basically, drink one 1 to 3 hours in advance of your test.

They attempt to mask the THC in your urine. You should combine these with Toxin Rid for consistent results.

If you don't, you still have at least 1/3 chance or so of failing your test. Just take a look at the ~33% 1-star reviews from people who fell prey to false claims and failed due to using the product alone (and these are the same-day detox drinks that are the most reputed in the industry, most other brands are EVEN LESS reliable). Many of the positive reviews are also from people who would have likely passed their test with or without a detox drink but since they drank it before they give it all the credit.

at home and see if you pass.

I'd say definitely get a pack of these.

There are several brands that will get the job done but these ones are dirt-cheap at less than a dollar per test and come in packs of 10.

Use them as assurance. I for one prefer to be certain I'll pass before taking a high stake drug test. It's a good way lessen anxiety before your urine test.

Note however that, although these are surprisingly accurate, they do not quite compare to a lab examination of your urine sample, so use common sense and make sure you detox even though your strip came out negative, just in case.

As a reminder, if you choose to use Toxin Rid above, you can get a fancier home urine drug test kit included for free when ordering. If so, only get these if you think you'll find use for more than one.

<u>Certo drug test method ingredients</u> – This method is what I use in combination with Toxin Rid to pass blood tests.

Many people use this for urine tests in place of a same day THC detox drink, and I'd say it's very effective when combined with Toxin Rid in advance.

Perhaps even more-so than THC detox drinks, although a tad bit less convenient and with a greater risk of your urine sample being too diluted should they test for that.



Aloe Rid Detox Shampoo (<- the old version) — this is for hair follicle drug tests only and is by leaps and bounds the most highly regarded THC detox shampoo among people who passed the hair test and lived to tell the tale.

Many forums will have success stories attesting to this.

It is a vital part of <u>the Macujo method</u> which is considered (and has been for a good while) the best way to pass this test at the moment.

It comes with Ultra Clean(see below) since they work in conjunction, and it needs to be the old version to work. <u>TestClear</u> sells this one and I'm sure they would gladly answer any questions about it in their support live chat that I mentioned earlier.

<u>Ultra Clean Shampoo</u> – this is my main same day shampoo for hair follicle drug tests, to be used on the day of the test.

It is one of the most popular and recognized shampoos for THC detox when combined with Aloe Rid.

It is no miracle on its own however and needs the synergy of Aloe Rid (which is also why it is included when ordering Aloe Rid). So combine it with using Aloe Rid in advance if you've had anything more than a couple of joints in the last three months.

Don't gamble with your hair drug tests, they are highly accurate tests. Using this product

solo would be doing just that, and at your own risk.

<u>Oral Clear Gum</u> – An awesome product for saliva drug tests.



Use it before your mouth swab drug test to hide any traces of THC. It takes only 30 seconds to clear your saliva of toxins and

then leaves you with a half an hour window to leave your clear oral sample.

It is also strong enough on its own in that you don't need any other supplementary detox products.

And did I mention it's a GUM (it's actually the only gum on the market)? Super convenient and discrete.

I used to get by with using mouth washes together with a short (3-5 days) Toxin Rid detox but this product is actually way better in several ways:

The problem with most mouth washes is that you need to be gargling and swishing it around for a while, spit it out somewhere, wait a few minutes, and then you have up to a 15 minute window where you must leave your saliva sample for it to be clean.

Timing it perfectly is stressful. What if the test gets delayed by just 10-15 minutes? Your mouth wash just lost its effect.. What if it's a random test and you can't suspiciously start swishing your mouth wash on the spot, let alone wait 5 minutes for it to take effect..

Oral Clear is boasting a 200% money back guarantee and says on it that no abstinence period from drugs is required, but I'd recommend that you still abstain at least a day just to be sure. It's of the Clear Choice brand which is one of the pioneers in the industry, having been around since 1993 (yep, that's 22 years!) and their main website is www.testnegative.com.



<u>Sub-Solution powdered urine kit</u> – This is basically a *reliable* powdered urine kit with a hot advantage (this is bad, yet intended, pun and you'll likely get it soon).

Many people try to pass their drug tests with various synthetic urines. That was a good way to pass a while back, but times change. Now the internet is filled with aged misleading information on how well this or that synthetic urine works.

Synthetic urine still works and helps people pass every day, but supervision has also become stricter in many places. Drug testing companies have gotten better at detecting if the pee is fake or not. I'd really only trust Sub-Solution, Purine and possibly QF plus as substitute for my piss.

I use this for unsupervised tests in the cases where I've had very little time, if any, to do my drug test detox. Usually I then test positive on my home urine drug test strip as well.

A Qcarbo or Stinger alone before the test simply has too big of an error margin and doesn't cut it for me.

If the draw coreaning is uncunamical this is a niece of cake and thus a good ontion. If it's

in the drug screening is unsupervised this is a piece of case and thus a good option. It is supervised it gets a lot trickier. It is still usually doable under supervision but detox is strongly preferred.

What Sub-Solution has over the competition is mainly the possibility to heat your urine instantly on the spot with a chemical powder. So you don't have to wait 15-30 minutes for your heating pad to heat it up, but can simply mix a little heating powder into it. So if your urine isn't the right temperature once you're in the booth leaving your sample, you're not screwed.

It is of the same brand as Oral Clear, namely Clear Choice and is also covered by a 200% money back guarantee by www.testnegative.com.

But before deciding on synthetic urine, you better check out <u>Synthetic Urine – The Adultonly Guide On How To Pee.</u> This will help you decide if it's a good idea for your test and how to do it.

Steps to pass the different marijuana drug tests

I highly suggest you also take a look at <u>the complete guides for passing the various drug</u> <u>tests</u>, you can find them below as well and they get in to the best ways of passing the four drug tests in much more depth.

To summarize, below is what to do to pass your drug tests, based on experience and on well-documented methods across the web with lots of happy success stories. Any marijuana detox products mentioned are covered in the list of products I use above.

Urine Test:

Mandatory THC detox when possible: Abstain from weed for as long as possible, preferably more than a week, Toxin Rid 5 to 10 day detox depending on time, Qcarbo/Stinger same day of test, avoid exercise before test.

Recommended compliment: DEERS (Short for Drink Eat Exercise Rest Sweat, see paragraph on natural marijuana detoxification aids above for further detail), test yourself with home urine drug test kit.

Optional: Sub-Solution (powdered synthetic urine) for unsupervised test

See the complete guide on how to pass your urine test fast on this page.

Sidenote: Some think they can get away by just claiming the result was a false positive, but in reality those are so rare that excuse is never going to work out.

Hair test;

Mandatory THC detox when possible: The Macujo method (Aloe Rid most important), Ultra Clean Shampoo the day of test.

Optional: Hair Confirm follicle home test to test yourself.

Saliva Test;

Mandatory THC detox when possible: Abstain from weed for 1-2 days, Oral Clear right before test.

Recommended compliment: Brush teeth thoroughly and use regular mouthwash daily, DEERS

Blood test;

Mandatory THC detox when possible: Abstain from weed for 3-7+ days, Toxin Rid 5 to 10 day detox, do the Certo method before test, avoid exercise right before test.

Recommended compliment: DEERS

This could vary of course, considering time is your best friend when detoxing weed. If you use the 3-day Toxin Rid and do as you say with water and some activity, and then get tested in 3 weeks, that should definitely be enough to pass. I usually do 10 day Toxin Rid for my urine tests or at the very least 5 days if I haven't been smoking too much, which is already almost twice as long as the 3-day program, so definitely get hold of a same-day detox drink to take before your test in case you're tested sooner than 3 weeks from today.

The one day or same day detox drinks you drink a few hours before the test. This should be included in the instructions of the drink when you buy it. Generally you drink it, wait 30-60 min for it to take effect, and then you have a window of a few hours (again see instructions since it depends on your product) where you should take your test before the masking effects wear off.

But as in your second example where you smoke the night before, a same day detox drink isn't going to be reliable at all and your best bet is on being very lucky basically. It never really is enough which is why I only recommend a detox program (as mentioned in this post) while abstaining, in combination with a masking same day drink. In cases like the one you describe where you don't want to abstain, synthetic urine is what you'd want to use, granted it isn't a supervised test.

It is a fact however, that drug testing companies are constantly evolving, and substituting fake pee for your own has become harder to get away with than it once was.

Not only has the supervision become stricter, making it more difficult to hide and use fake urine..

But nowadays the labs can also test for

this, meaning they can detect if the urine isn't from a human body in origin.

It's still very possible to pass your test using synthetic urine though. You just need to know WHEN it's a good option, when it isn't, and use the best synthetic urine brands that are reliable and won't be detected as ingenuine.

And a bunch of other things..

I will cover all you need to know on this very page, so just keep reading.

I will list the factors you need to consider when deciding if using fake urine is a good option to pass <u>your drug test</u> or not, what markers the labs use to decide whether the urine is fake or the real deal and what brands sell the best synthetic urine (a.k.a. urine that actually works).

It's toxin free and what the testing labs use to calibrate their equipment, since it gives the same, consistent result.

It's a little more complicated though nowadays than it once was, and not always the best option.

But as long as you use quality stuff and know when you may want to avoid using it, you should be all good.

I'll explain just that below.

Work for what? There are several uses for synthetic urine, such as in science and experiments, much cleaner and more convenient. Great for pranks, and definitely kinder to the victim(s) than the human alternative. Repelling animals (mosquitos anyone?). As medicine (I know, WTF), but urine therapy has been used traditionally in some indian cultures and in ayurveda.

Will you be watched?

As mentioned earlier, using synthetic urine to simulate real pee is definitely a viable option for **some** piss tests. I have used it, but I would really only recommend this if you

know that the following factors hold true:

- 1.) Your urine test is not supervised (no one will be watching you as you pee in the cup).
- 2.) It is a supervised test but you KNOW that they won't make you pull down your undies

to your knees and your shirt above your navel. They do this more often as of lately due to the many people who beat urine tests with fake pee in the past, relying on hiding it in their underwear and/or on fake penises/urinators with backstraps (Whizzinator, anyone?).

- 3.) You use a reliable brand of fake urine. There are many rip-off products out there that either never worked or did work once upon a time. Drug companies have become better at detecting if urine is synthetic or not though, so low quality brands are highly unreliable. I'd recommend <u>Sub-Solution</u> which is what I have the most experience with and what me and my friends use when we need to. It's a powdered urine kit.
- 4.) You won't pass the test without it. Let's say you smoked a huge amount of cannabis on the day of your drug test. Then the Certo method has too big of a margin of error. Detox is not a realistic method for you, but using urine that isn't yours to test negative, is.

So, if the above mentioned terms fit with you and your urine drug test, then by all means go ahead, it may be your best bet and you'll likely pass it without any problems.

If they don't however, or if you're not so sure..

Then cleansing yourself through proper <u>THC detox</u> and using your real pee would be the much safer route to <u>pass your urine drug test</u> in my opinion.

The first check after obtaining your urine sample is usually done using an EMIT (short for enzyme multiplied in the proteins of this gives a positive result; is then sent to an accredited lab with the required laboratory equipment and a CC-MS (short for gas chromotography-mass spectrometry) is performed to prove that illicit substances/metabolites are present and avoid any mistakes.

f curious, here's a great and short video to get the hang of the basics of how the urine lrug test analyzation of your sample works. A color spectrum is used to compare the color roduced on the strip by your urine sample to the color a clean urine should produce.

Where do I hide it during a supervised urine test?

A great question which can be tough to answer.

It depends a lot on the specific testing facility, and thus you may want to do some research about what company does the testing for your job/organisation and their methods.

As I touched on in key factor nr. 2 above, sometimes you may be compelled to pull your

pants down to your knees and your shirt up above your navel. I've also heard of testing facilities that make you put some sort of bath robe on. This isn't the norm however, so do your research on this one.

If it's an unsupervised test you shouldn't really need to hide it at all, just use some common sense.

Here are some ideas on where to hide it for a supervised test;

- Bag taped to your inner thigh. This is a real classic.
- Wearing dual undies and keeping the bag in-between them.
- Up your vagina. (If you're a female that is. And yes, I'm very serious, this is a good option).
- In a special <u>synthetic pee belt</u> above your navel. If you read about possible inspection methods above will understand why this is actually a really clever way.

Tried any of the above? What's your personal hiding spot that has worked? Please let me and others know in the comments. If it's good I might add it to the list.

The adulteration check and markers


An important part of the drug testing process of urine samples is the adulteration check.

This is done to determine whether the specimen being tested is genuine and not fake/synthetic, is diluted, or if it has been tampered with in order to mask drug metabolites in any way.

Here are a few important things the test examines;

- pH Normal pH in urine ranges from 4.6 and 8 but slightly more or less may be acceptable. If yours not within the range it is a clear sign of adulteration.
- Specific gravity This reveals the concentration of solutes and density of your urine sample compared to water. The reference range for specific gravity is 1.005-1.030.
- ◆ Temperature It should be between 90 °F and 100 °F (or 32-38 °C) to not look suspicious.
- Creatinine levels If your sample isn't <u>above 15 mg/kg</u> of bodyweight it indicates

- <u>Uric acid</u> No uric acid means non-genuine, substituted pee.
- Glutaraldehyde Present in many urine masking agent products and not naturally
 present in urine. Thus, an obvious sign a sample has been tampered with,
- Nitrate Same as above, shouldn't be present i natural pee.
- <u>Urea</u> One of the more recent compounds labs have started testing for. If it isn't
 present in your sample, they will know it's nothing but fake piss.
- Color and odor Although not officially part of the test, if your pee looks and smells like water, it's common sense to suspect it may be diluted which may warrant extra testing (which is why b-vitamins are so common when diluting urine, since they add a yellow color).

You can probably understand now why you need good quality synthetic urine in order to not get caught. Which brings us to...

Best synthetic urine – Reviews of brands and where to buy them

Below I'll list and briefly review the two best synthetic urine kit brands and my personal preferences.

When reading synthetic urine reviews online and other people's experience with synthetic urine, on forums and such, it's important to look at the date. Drug testing evolves constantly, which means the same brands and methods may or may not still be effective. If older than a year, you may want to look for something more recent.

Sub-Solution powdered urine kit review

This is the synthetic urine I use the most. It has an edge over the competition in that if you need to, you can heat it up in a matter of seconds, not having to wait half an hour as with

heating pads.

This is because it comes with a chemical heating powder. You can mix some of this with the urine in order to heat it up on demand.



I was skeptical at first in regards to this way of heating it since it was new to me. Could it be detected? Is it hard to hit the right temperature? But it stands clear to me that it is the better way of doing it. It can't be detected and heating it up is dummyproof. Of course a temperature strip is included as well.

<u>Sub-Solution</u> clearly outshines other brands at times when you're in the booth leaving your urine sample and you notice you're urine isn't of high enough temperature. Where a hand-

warmer or heating pad wouldnt be able to get the job done in time and you'd be screwed, simply mixing a little heating powder in to it instantly does the trick.

Same goes for random urine tests. If you're compelled to take a test on the spot, even if you have your fake urine with you, you don't have 30 minutes of time to heat your sample. Random test beating = instant heating.

Made by Clear Choice, a well-reputed company and a pioneer that's been around for 22 years (since 1993), it is sold from their main website www.testnegative.com and comes with a 200% money back guarantee.

Purine powdered urine kit review



I used to use Purine pretty much exclusively for a while, but now find Sub-Solution superior due to its fast heating method. Purine is still decent and when needed I get it here from TestClear. Includes a heater and temperature strip and of course instructions, although you may want to add an extra heater (in case your test gets delayed) and a digital thermometer at checkout.

It is in powder form and when mixed it has the right qualities needed to pass the urine drug test. As you know I prefer to not take any risks, and from what I understand it's as close as you get to actual human urine. On par with Sub-Solution in that regard.

What I like particularly though is that it actually behaves like urine should. This avoids unnecessary suspicion that may warrant further testing of your sample. It looks like urine, smells like urine and foams when shaken up.

Not that I like the smell of urine in general, but *in this case* I definitely do ;). Natural urine smells like urine, so should this.

Quick Fix Plus review

Quick Fix is likely the most well-known synthetic pee brand. They have an original version and a plus version.

The reason I'm mentioning Quick Fix *Plus* in particular is because if you were to use Quick Fix for your UA, it definitely needs to be the more expensive 6.1 plus version. The difference between the two is that plus contains uric acid and far too many labs test for this in 2015 to use a sample without it.

I'm really not sure why they bother selling a urine version without uric acid in it, since it is bound to give them unhappy customers who failed their test.

You need to heat it with a heater to desired temperature, which takes some time.

The QF urine does not smell of anything in particular, which gives Purine the edge over QuickFix, most other factors being the same. Sub-Solution, in my opinion, has an edge over both of them but also costs slightly more. Passing your test will always be worth it though.

There are other options in the industry such as U pass, Magnum Detox, Urine Luck, Psure, Clean Stream etc. if you choose to test those instead. How well they compare to Sub-Solution and Purine I can't say with certainty.

Just remember to always do your research properly beforehand or it can cost you dearly.

As for your question, I know Quick Fix for example has a very long shelf life (~2 years) and can be re-heated almost indefinitely. Just keep it air-tight wherever you store it, belt or original bottle, and it should be fine I'd say, no need to refill every day.

Since I don't know exactly how the drug tests are performed at your factory it's hard for me to say how it will work out in practice though. The main concern is probably heating it right before the test. This takes a little time but if you aren't made to take a piss on the spot, it should work. And supervision as well, since Whizzinator is vulnerable to thorough "inspections" but it seems to have worked for you before so you likely know the drill of you work place's testing procedure.

You can also reach out to the support of the synthetic urine brand you plan using for specific questions, TestClear for example has a live-chat on their website.

Please review this draft to ensure it is consistent with your intent. After reviewing the 3 materials you sent over, I determined that I could draft these new statutes in Chapter 4

961, which contains the Uniform Controlled Substances Act and some miscellaneous 5

provisions. 6

I created in the draft a definition of a "masking agent" that covers any device or substance "intended to defraud, circumvent, interfere with, or provide a substitute for a bodily fluid in conjunction with, a lawfully administered drug test." In the draft, the penalties associated with possessing or using, manufacturing or delivering, and advertising a masking agent are similar to the penalties assessed for the same acts as $\overline{11}$ they relate to drug paraphernalia. If you would like a different definition or different 12 penalties, please let me know. 13

There are a few other places in the statues where I thought it was appropriate to add the new violation in the draft, masking agents are subject to seizure and forfeiture. violations relating to masking agents may disqualify a person from operating a travelling sales crew, and a person is immune from prosecution for possessing a masking agent if the person summons emergency aid for another person who is suffering an overdose. I did not add the masking agent provisions to statutes that would allow for local regulation of the agents or for special provisions for minors. I felt that those were beyond the scope of the request, but I can add them if you wish.

Please let me know if you would like to discuss any provisions or if you would like any other changes. When the draft meets your approval, I will redraft it in introducible form.

AN ACT ...; relating to: the use of possession, manufacture of distribution, of and advertisement of a masking agent, and creating a criminal penalty.

Analysis by the Legislative Reference Bureau

This bill criminalizes the use of possession, manufacture of distribution, or advertisement of any substance or device that is intended to defraud, circumvent, interfere with, or provide a substitute for a bodily fluid in conjunction with a lawfully administered drug test (masking agent).

Under the bill, a person who uses or who possesses with intent to use a masking agent is subject to a fine up to \$500, imprisonment for 30 days, or both. A person who delivers or manufactures a masking agent is subject to a fine up to \$1000, imprisonment for up to 90 days, or both. A person who advertises (for sale a masking agent/may be fined up to \$500, imprisoned for up to 30 days, or both.

Heather,

Please review this draft to ensure it is consistent with your intent. After reviewing the materials you sent over, I determined that I could draft these new statutes in Chapter 961, which contains the Uniform Controlled Substances Act and some miscellaneous provisions.

I created in the draft a definition of a "masking agent" that covers any device or substance "intended to defraud, circumvent, interfere with, or provide a substitute for a bodily fluid in conjunction with a lawfully administered drug test." In the draft, the penalties associated with possessing, using, manufacturing, delivering, and advertising a masking agent are similar to the penalties assessed for the same acts as they relate to drug paraphernalia. If you would like a different definition or different penalties, please let me know.

There are a few other places in the statutes where I thought it was appropriate to add the new violation; in the draft, masking agents are subject to seizure and forfeiture, violations relating to masking agents may disqualify a person from operating a traveling sales crew, and a person is immune from prosecution for possessing a masking agent if the person summons emergency aid for another person who is suffering an overdose. I did not add the masking agent provisions to statutes that would allow for local regulation of the agents or for special provisions for minors. I felt that those were beyond the scope of the request, but I can add them if you wish.

Please let me know if you would like to discuss any provisions or if you would like any other changes. When the draft meets your approval, I will redraft it in introducible form.
