Today H-15

- 1 **AN ACT to create** 70.03 (1m) of the statutes; **relating to:** assessing certain items
2 as real property for property tax purposes.

Analysis by the Legislative Reference Bureau

This bill provides that all of the following items are considered real property for purposes of assessing property taxes:

1. Cooking ranges.
2. Furnaces.
3. Water heaters used for a special purpose.
4. Communications, radio station, and television station towers.
5. Pinspotters.
6. Car wash equipment.
7. Indoor theater seats.
8. Aboveground tanks.
9. Surface mounted lifts used to provide automotive services.
10. Alarm systems.
11. Surveillance systems.
