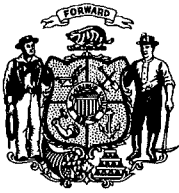

1 AN ACT relating to: local youth apprenticeship grants and making an

Analysis by the Legislative Reference Bureau

This bill increases the amount appropriated to the Department of Workforce Development for local youth apprenticeship grants by \$500,000 in fiscal year 2016-17. Currently, \$2,223,700 is appropriated in that fiscal year for those grants, which are awarded to local partnerships consisting of one or more school districts, other public agencies, nonprofit organizations, individuals, and other persons for the implementation and coordination of local youth apprenticeship programs.

For further information see the *state* fiscal estimate, which will be printed as an appendix to this bill.
