January 29, 2016 - Introduced by Representatives STEFFEN, ALLEN, BERCEAU, EDMING, HORLACHER, JOHNSON, T. LARSON, MASON, A. OTT, RIPP, SPIROS and SUBECK, cosponsored by Senators L. TAYLOR and WIRCH. Referred to Committee on Children and Families.

1 AN ACT to create 118.018 of the statutes; relating to: physical education in
2 public schools.

Analysis by the Legislative Reference Bureau

This bill requires that every school district operating grades kindergarten to five ensure that pupils in those grades participate in physical education for at least 30 minutes each day on which school is held.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

3 SECTION 1. 118.018 of the statutes is created to read:

4 **118.018 Physical education instruction.** A school board of a school district
5 operating grades kindergarten to 5 shall ensure that pupils in those grades
6 participate and receive instruction in physical education for at least 30 minutes each
7 day on which school is held.
