Generally, under current law, the fee for an annual sticker is \$24.50 for a Wisconsin vehicle and \$34.50 for an out-of-state vehicle. If the person who owns a Wisconsin vehicle is a resident senior citizen, the fee for an annual sticker is \$9.50. If the person applying for an annual sticker or a member of his or her household owns a vehicle for which a current annual sticker has been issued, the fee is \$12 for a Wisconsin vehicle and \$17 for an out-of-state vehicle. This bill increases each of these fees by \$3.
