Chris: I am having trouble understanding what you want. I have two questions:

- 1. You indicate you want the appropriation to be continuing, but this is already a continuing appropriation. See 20.001 (3) (c): Continuing appropriations are indicated in ss. 20.115 to 20.875 by the introductory phrase, "as a continuing appropriation," "all moneys received from," or "all moneys transferred from." (emphasis added). So, your instruction is not clear to me.
- 2. If the appropriation, which is for moneys received from the department for the department and from other state agencies for services rendered, is not for "all moneys received," then what would it be for. Is the intent to restore the sum certain language (amounts in the schedule)? Even so, note that "all moneys received" appears in both the current law text and the underscored text in the draft. Do you want to get rid of "all moneys received" in both spots? And, replace that language with what?
