

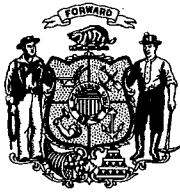

Statutory Language Change Request

The department requests to create new numeric 333 in the appropriation under s. 20.465(3)(g) and make that alpha appropriation continuing, all funds received. The continuing appropriation is needed because the program charges law enforcement agencies for the actual cost of shipping and transportation of items. This program revenue appropriation will be used for handling law enforcement agency enrollment fees and transportation costs.

Current language:
