Intent:

Eliminate a discrepancy relating to eligibility for admission into homes for parents of veterans and clarify the qualifications for Assistance to Needy Veterans program to remove some restrictions that limit participation in the program. Amend sections 45.02 and 45.51, Stats. as follows:

45.02(2) Except as provided in sub. (3), 45.40, and s. 45.51 (6m) to be eligible for benefits under this chapter an applicant shall be a resident of (strike "and living in") this state at the time of making application or the veteran from whom the applicant derives eligibility is derived meets one of the following conditions:

(a) His or her selective service local board, if any, and home of record at the time of entry or reentry into active service as shown on the veteran's report of separation from the U.S. armed forces for a qualifying period were in this state.

- (b) The veteran was a resident of this state at the time of entry or reentry into active duty.
- (c) The veteran was a resident of this state for any 12-month period after reentry into service and before the date of his or her application or death.
- 45.51 Eligibility for membership.
- (1) General statement. Within the limitations of veterans home, the department may admit to membership in veterans homes persons who meet the qualifications set forth in this section.
- (2) Eligibility
- (a) The following persons are eligible for benefits under this subchapter if they meet the applicable requirements of this subchapter:
- 1. A veteran.
- 2. A person who has served on active duty under honorable conditions in the U.S. armed forces or in forces incorporated as part of the U.S. armed forces for 90 days or more and at least one day during a war period or under section 1 of executive order 10957, dated August 10, 1961.
- 3. A spouse or surviving spouse of a person under subd. 1. or 2., or parent, any of whose children died while serving in the Armed Forces.




