Hi Rick,

I have changes on two of my drafts that will hopefully be relatively small (at least in the grand scheme of things):

1. For the consolidation of agency services appropriations draft (LRB-0337), Section 9201(1) should also provide for the transfer of assets in the appropriation under s. 20.505(1)(ke). Though relatively small, the assets and unencumbered balance would all be transferred to (1)(kL) on the effective date of the budget bill.
2. The Building Trust Fund draft (LRB-1039) should be adjusted so that the secretary may transfer \$3 million from the unencumbered balance of appropriation (1)(kc) before July 1, 2016. The intent of this change would be to provide a one-time transfer to the building trust fund of a set amount in fiscal year 2015-16 only.
