2 SECTION 9112. Nonstatutory provisions; Employee Trust Funds.

3 (1) PROCUREMENT POSITION TRANSFER. (a) *fix comparison text NS: par* Employee transfers. On the effective
4 date of this paragraph, 1.0 FTE position and the incumbent employee holding the
5 position in the department of employee trust funds who performs duties relating to
6 procurement, as determined by the secretary of administration, is transferred to the
7 department of administration.

SECTION 9112

1 (b) *Employee status.* The employee transferred under paragraph (a) has all the
2 rights and the same status under chapter 230 of the statutes in the department of
3 administration that he or she enjoyed in the department of employee trust funds
4 immediately before the transfer. Notwithstanding section 230.28 (4) of the statutes,
5 no employee so transferred who has attained permanent status in class is required
6 to serve a probationary period.
