In the schedule under section 20.005 (3) of the statutes for the appropriation to the department of corrections under section 20.410 (1) (a) of the statutes, as affected by the acts of 2015, the dollar amount is increased by \$2,393,000 for the first fiscal year of the fiscal biennium in which this subsection takes effect to increase the number of FTE positions for the department by 54.0 3rd shift tower staffing positions.
