1 At the locations indicated, amend the bill, as shown by senate substitute
2 amendment 1, as follows:

3 **1.** Page 181, line 5: decrease the dollar amount for fiscal year 2015-16 by
4 \$560,900 and decrease the dollar amount for fiscal year 2016-17 by \$4,429,400 for
5 the purpose of decreasing funding for adult correctional services.

6 **2.** Page 220, line 13: increase the dollar amount for fiscal year 2015-16 by
7 \$560,900 and increase the dollar amount for fiscal year 2016-17 by \$4,429,400 for
8 the purpose of providing grants to counties that provide alternatives to prosecution
9 and incarceration.

10 **3.** Page 266, line 6: increase the dollar amount for fiscal year 2015-16 by
11 \$88,200 and increase the dollar amount for fiscal year 2016-17 by \$88,200 for the
12 purpose of funding the position of a statewide coordinator for problem-solving
13 courts.

15 qualify for the highest available enhanced federal medical assistance percentage.

17 assistance percentage, or if the enhanced federal medical assistance percentage
18 obtained by the department is lower than printed in federal law as of July 1, 2013,

20 submit to the joint committee on finance a fiscal analysis comparing the cost to
21 maintain coverage for adults who are not pregnant and not elderly at up to 133
22 percent of the poverty line to the cost of limiting eligibility to those adults with family
