Under current law, the Dwelling Code Council in the Department of Safety and Professional Services (DSPS) recommends a uniform dwelling code for adoption by DSPS and makes other recommendations to DSPS concerning the regulation of oneand two-family dwellings. This bill renames that council the Uniform Dwelling Code Council.

Also under current law, the Building Code Council in DSPS advises DSPS about the rules of DSPS and other issues related to the construction, repair, and maintenance of public buildings and buildings that are places of employment. This bill renames that council the Commercial Building Code Council.
