1 At the locations indicated, amend the bill as follows:

2 **1.** Page 3, line 15: delete lines 15 to 17 and substitute “the method of abortion
3 not used would have increased the risk to the woman.”

4 **2.** Page 6, line 21: after “survive.” insert “Nothing in this paragraph requires
5 a physician performing an abortion to employ a method of abortion which, in his or
6 her medical judgment based on the particular facts of the case before him or her,
7 would increase the risk to the woman.”
