



## 2015 ASSEMBLY BILL 685

1     **AN ACT** *to renumber and amend* 20.427 (1) (n); *to amend* 20.427 (1) (m), 20.445  
2           (1) (n) and 20.445 (1) (o); and *to create* 20.427 (1) (km) of the statutes; **relating**  
3           **to:** transferring federal moneys received by the Department of Workforce  
4           Development to the Labor and Industry Review Commission and making an  
5           appropriation (suggested as remedial legislation by the Legislative Fiscal  
6           Bureau).

*Analysis by the Legislative Reference Bureau*

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

LAW REVISION COMMITTEE PREFATORY NOTE: This bill is a remedial legislation proposal, requested by the Legislative Fiscal Bureau and introduced by the Law Revision Committee under s. 13.83 (1) (c) 4. and 5., stats. After careful consideration of the various provisions of the bill, the Law Revision Committee has determined that this bill makes minor substantive changes in the statutes, and that these changes are desirable as a matter of public policy.

7     **SECTION 1.** 20.427 (1) (km) of the statutes is created to read:

**ASSEMBLY BILL 685****SECTION 1**

1           20.427 (1) (km) *Equal rights; other moneys.* All moneys transferred from the  
2 appropriation account under s. 20.445 (1) (o) for the performance of the functions of  
3 the labor and industry review commission related to the review of decisions by the  
4 division of equal rights in the department of workforce development and all other  
5 moneys transferred from state agencies to the appropriation account under this  
6 paragraph for the purposes for which the transfer is made.

NOTE: Creates an appropriation account for the Labor and Industry Review Commission (LIRC) that provides for transfer of federal moneys for the performance of the functions of LIRC related to the review of decisions by the Division of Equal Rights (ERD) in the Department of Workforce Development (DWD) from the DWD appropriation account for federal moneys related to the activities of the ERD. The created appropriation account also provides for transfer of all other moneys transferred from state agencies to the account.

7           **SECTION 2.** 20.427 (1) (m) of the statutes, as affected by 2015 Wisconsin Act 55,  
8 is amended to read:

9           20.427 (1) (m) *Federal moneys.* All federal moneys ~~not appropriated under par.~~  
10 ~~(n) that are received from the federal government~~ as authorized by the governor  
11 under s. 16.54 for the functions of the labor and industry review commission.

NOTE: Modifies the LIRC appropriation account for federal moneys to provide for the appropriation for its functions of all federal moneys directly received by LIRC.

12           **SECTION 3.** 20.427 (1) (n) of the statutes, as affected by 2015 Wisconsin Act 55,  
13 is renumbered 20.427 (1) (k) and amended to read:

14           20.427 (1) (k) *Unemployment administration; federal moneys.* All federal  
15 moneys ~~received as authorized by the governor under s. 16.54~~ transferred from the  
16 appropriation account under s. 20.445 (1) (n) for the performance of the functions of  
17 the labor and industry review commission under ch. 108.

NOTE: Modifies the LIRC appropriation account for unemployment administration to provide for the transfer of moneys from the DWD appropriation account for federal moneys received for employment assistance and unemployment insurance administration to the LIRC appropriation account for unemployment administration.

18           **SECTION 4.** 20.445 (1) (n) of the statutes is amended to read:

**ASSEMBLY BILL 685**

1           20.445 (1) (n) *Employment assistance and unemployment insurance*  
2 *administration; federal moneys.* All federal moneys received, as authorized by the  
3 governor under s. 16.54, for the administration of employment assistance and  
4 unemployment insurance programs of the department, for the performance of the  
5 department's other functions under subch. I of ch. 106 and ch. 108, and to pay the  
6 compensation and expenses of appeal tribunals and of employment councils  
7 appointed under s. 108.14, to be used for such purposes, except as provided in s.  
8 108.161 (3e), and, from the moneys received by this state under section 903 (d) of the  
9 federal Social Security Act, as amended, to transfer to the appropriation account  
10 under par. (nb) an amount determined by the treasurer of the unemployment reserve  
11 fund not exceeding the lesser of the amount specified in s. 108.161 (4) (d) or the  
12 amounts in the schedule under par. (nb), to transfer to the appropriation account  
13 under par. (nd) an amount determined by the treasurer of the unemployment reserve  
14 fund not exceeding the lesser of the amount specified in s. 108.161 (4) (d) or the  
15 amounts in the schedule under par. (nd), and to transfer to the appropriation account  
16 under par. (ne) an amount not exceeding the lesser of the amount specified in s.  
17 108.161 (4) (d) or the sum of the amounts in the schedule under par. (ne) and the  
18 amount determined by the treasurer of the unemployment reserve fund that is  
19 required to pay for the cost of banking services incurred by the unemployment  
20 reserve fund, and to transfer to the appropriation account under s. 20.427 (1) (k) an  
21 amount determined by the treasurer of the unemployment reserve fund.

NOTE: Modifies the DWD appropriation account for federal moneys received for  
employment assistance and unemployment insurance administration to transfer from  
that appropriation account an amount determined by the treasurer of the unemployment  
reserve fund to the LIRC appropriation account for unemployment administration.

22       **SECTION 5.** 20.445 (1) (o) of the statutes is amended to read:

**ASSEMBLY BILL 685****SECTION 5**

1           20.445 (1) (o) *Equal rights; federal moneys.* All federal moneys received for the  
2 activities of the division of equal rights in the department, to be used for those  
3 purposes, and to transfer to the appropriation account under s. 20.427 (1) (km).

NOTE: Modifies the DWD appropriation account for federal moneys received for the  
activities of the ERD to transfer moneys from that appropriation account to the LIRC  
appropriation account for equal rights created under SECTION 1 of the bill.
