Mike,

I found the question we had been asked to relay to you. It was from a staff attorney for the Children's Court in Milwaukee County.

The request was to look at changing s. 995.20, Legal holidays, relating to the way the Martin Luther King holiday is listed. The suggestion is to change the statute to read "the third Monday in January (which shall be the day of celebration for January 15)" rather than the current listing of just "January 15." There are 2 issues with the current wording: (1) the 15th does not often fall on the third Monday; and (2) not all counties observe MLK day as a legal holiday. (NOTE: I asked the Wisconsin Counties Association for a list of counties that observe/don't observe MLK day; they would have to survey members to generate a list.) We've been told either or both of these conditions have resulted in counties having to staff the courthouse on the third Monday of January (because it is not the legal holiday) for cases with short timelines (e.g. s. 48.21, Stats.).

The suggested change in language would treat the MLK holiday the same way as Memorial Day is treated in the statutes.

Let me know if you think this meets the parameters of the Law Revision Committee. Thanks for your help.


