We would to the amendment to:

- Undo the changes to cemetery salesperson licensure requirements. (Section 94 I believe). We would like to keep current law, the 20 plot standard for licensing.
- Eliminate the acreage perimeter that decides if a cemetery must be registered or licensed. The bill changes current law from 5 to 3 acres. We would like to eliminate acres so that cemeteries are sorted by the size of their trust funds. (section 90)

SENATE AMENDMENT,

TO SENATE BILL 302

At the locations indicated, amend the bill as follows:

1. Page 30, line 1: delete lines 1 to 9 and substitute:

"440.91 (1) (a) Any cemetery authority that operates a cemetery that is 5 acres or more in size, that sells 20 or more cemetery lots or mausoleum spaces at a cemetery during a calendar year, or that has \$100,000 \$50,000 or more in trust fund accounts for a cemetery shall apply to the board for a license for that cemetery. A cemetery authority that operates more than one cemetery shall apply for a separate license for each cemetery that is 5 acres or more in size and for each cemetery at which it sells 20 or more burial spaces or at which it has \$100,000 \$50,000 or more in trust fund accounts."

2. Page 30, line 20: delete the material beginning with "440.91" and ending with "accounts." on page 31, line 3 and substitute:

"440.91 (1m) (a) Except as provided in sub. (6m), any cemetery authority that operates a cemetery that is less than 5 acres in size, that sells fewer than 20 cemetery lots or mausoleum spaces at a cemetery during a calendar year, or that has less than \$100,000 \$50,000 in trust fund accounts for a cemetery shall register with the board. A cemetery authority that operates more than one cemetery shall submit a separate registration to the board for each cemetery that is less than 5 acres in size, that sells fewer than 20 cemetery lots or mausoleum spaces at a cemetery during a calendar year, or that has less than \$100,000 \$50,000 in trust fund accounts."

3. Page 31, line 4: delete lines 4 to 14.
