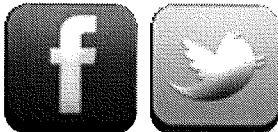

- 5 "**SECTION 7e.** 66.1105 (4m) (b) 2m. of the statutes is repealed."
- 6 **3.** Page 6, line 20: before that line insert:
- 7 "**SECTION 8m.** 66.1105 (5) (cf) of the statutes is repealed."
- 8 **4.** Page 10, line 4: before that line insert:
- 9 "**SECTION 20m.** 66.1106 (14) of the statutes is repealed."
