Analysis by the Legislative Reference Bureau

This bill requires the Department of Health Services to award grants to counties or regions of counties for their mobile crisis teams to obtain training on recognizing and serving individuals with dementia.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

7 programs that create mental health mobile crisis teams under s. 46.536 (1) and to
8 provide training to mobile crisis teams on dementia under s. 46.536 (2).

1 At the locations indicated, amend the bill as follows:

2 1. Page 1, line 7: delete “(1)”.

3 2. Page 1, line 8: delete “s. 46.536 (2)” and substitute “2015 Wisconsin Act
4 (this act), section 3m (1)”.

5 3. Page 1, line 8: after that line insert:
