**ASSEMBLY AMENDMENT ,**

**TO ASSEMBLY BILL 790**

1 At the locations indicated, amend the bill as follows:

2       1. Page 1, line 7: delete “(1)”.

3       2. Page 1, line 8: delete “s. 46.536 (2)” and substitute “2015 Wisconsin Act ....  
4       (this act), section 3m (1)”.

5       3. Page 1, line 8: after that line insert:

6       “**SECTION 1m.** 20.435 (5) (cf) of the statutes, as affected by 2015 Wisconsin Act  
7       .... (this act), is amended to read:

8           20.435 (5) (cf) *Mobile crisis team grants.* Biennially, the amounts in the  
9       schedule for awarding grants to counties or regions to establish certified crisis  
10      programs that create mental health mobile crisis teams under s. 46.536 and to

1 provide training to mobile crisis teams on dementia under 2015 Wisconsin Act ....  
2 (this act), section 3m (1).”

3 **4. Page 2, line 1: delete lines 1 to 6.**

4 **5. Page 2, line 6: after that line insert:**

5 **“SECTION 3m. Nonstatutory provisions.”**

6 **(1) DEMENTIA TRAINING GRANTS.** From the appropriation under section 20.435

7 **(5) (cf)** of the statutes in fiscal year 2016–17 only, the department of health services  
8 shall award grants in the total amount of \$250,000 to counties or regions comprising  
9 multiple counties to obtain training for their mobile crisis teams on recognizing and  
10 providing services to individuals with dementia.

11 **(2) DEMENTIA TRAINING GRANT BASE ADJUSTMENT.** Notwithstanding section 16.42

12 **(1) (e)** of the statutes, in submitting information under section 16.42 of the statutes  
13 for purposes of the 2017–19 biennial budget bill, the department of health services  
14 shall submit information concerning the appropriation under section 20.435 **(5) (cf)**  
15 of the statutes as though the increase in the dollar amount of that appropriation by  
16 SECTION 4 of this act had not been made.”.

17 **6. Page 2, line 12: delete “s. 46.536 (2)” and substitute “SECTION 3m (1) of this**

18 **act”.**

19 **7. Page 2, line 12: after that line insert:**

20 **“SECTION 5m. Effective dates.** This act takes effect on the day after

21 publication, except as follows:

(1) The treatment of section 20.435 (5) (cf) (by SECTION 1m) of the statutes takes effect on June 30, 2017.”.
