Hi Marc,

Senator Lassa wanted me to ask you for 2 floor amendments to AB 731. The details are as follows:

- 1.) This mirrors the Committee Amendment for SB 604 that you drafted for Senator Lassa back in February. It is attached to this email.
- 2.) I assume this will probably have to be a substitute, but basically we want it to do the following:
 - a. We would like to maintain the creation of WI-based ABLE Accounts that were in 2015 Wisconsin Act 55 (but removed in AB 731), but we would also like to retain the "favorable tax treatments" that would impact contributions to or withdrawals from an out-of-state ABLE Account.
 - b. Basically we want there to be WI-based account, but also want to open up the out-of-state options so folks can utilize those. Kind of the "best of both worlds" option.

1. Page 2, line 3: after "disabilities." insert "(1)" to via A mendinent 2.

2. Page 2, line 12: after that line insert:

"(a) The department shall include information on its Internet site, on the web page that relates to this state's Wisconsin 529 College Savings Program, in the area concerning ABLE accounts, current information on each state that offers ABLE accounts, information on how residents of this state may participate in those ABLE accounts, and links to resources to provide information about ABLE accounts in those states. The department shall also provide such information in written materials it prepares about ABLE accounts.

(b) The department of financial institutions shall publish on its Internet site information about ABLE accounts similar to information described in par. (a).".
