Analysis by the Legislative Reference Bureau

This bill modifies limitations on hauling by a special interest vehicle.

Current law provides for a special category of vehicle registration for special interest vehicles, commonly known as "collector vehicles." A vehicle may be eligible for registration as a collector vehicle if the vehicle is at least 20 years old, has not been altered, and is being preserved for its historic interest, or if the vehicle is, with an exception, at least 25 years old and is a certain type of former military vehicle. Trucks, other than former military vehicles, that are registered as collector vehicles may not haul material weighing more than 500 pounds, not including passengers, pets, or a camper, lid, or cap mounted on the truck.

Subject: Collector Truck - Statute Change

Hi Zachary,

We sent off that Memorandum of Understanding draft to Lt. Mike Klingenberg earlier today. Thank you again for your help on this issue.

I spoke with Representative Murtha today about this. He would like to try and get a bill drafted that cleans up the language in the statute to something very similar to what we discussed yesterday.

Current statute, 341.266(2)(e) says:

- (e) The vehicle may be used as are other vehicles of the same type except that:
- 1. Motor vehicles may not transport passengers for hire.
- 2. Trucks may not haul material weighing more than 500 pounds, not including the weight of a camper, lid or cap that is mounted on the truck or the weight of any persons or pets riding within the driver's compartment, unless the truck is a former military vehicle.
- **3.** Except as provided in s. <u>341.09 (7)</u>, no special interest vehicle may be operated upon any highway of this state during the month of January unless the owner of the vehicle reregisters the vehicle under s. <u>341.25</u> and replaces the distinctive registration plates issued under par. <u>(c)</u> with regular registration plates or transfers regular registration plates to the vehicle.

We would like to change this to read something like:

- 1. "Motor vehicles may not transport passengers or goods for hire."
- 2. "Trucks may not carry material weighing more than 500 pounds, not including the weight of a camper, trailer, lid or cap that is mounted on or behind the truck or the weight of any persons or pets riding within the driver's compartment, unless the truck is a former military vehicle."
- 3. No change

Hopefully this language is clear enough to allow for a truck tractor with a fifth wheel attachment or a pintle hook attachment to be able to haul a trailer behind it. As we talked about yesterday, the term "haul" can be quite ambiguous. It also reaffirms that these vehicles may not be used for any commercial purposes (I'm curious if that part is necessary if there is any other relevant language). Would like to hear your opinion on it when you get a chance.

Three other questions Representative Murtha had -

- 1) Because we have the prohibition against commercial activity, will we need to add any language anywhere that specifically states that drivers of commercial trucks do not need CDLs and are not subject to Interstate or Intrastate Commerce regulations?
- 2) Are there any special types of registrations for antique/old trailers? It is my understanding that these collector plates only apply to motor vehicles, therefore no trailers can be registered this way, but my boss wanted clarification.
- 3) What is the carve-out for former military vehicles doing there? Is this something that has a lot of historical backing, and is it necessary?

I look forward to speaking you further about this. Thank you very much for all your help thus far.
