The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

5	SECTION 1. 29.083 (1) of the statutes is amended to read:
6	29.083 (1) DEFINITION. In this section, "activity associated with lawful hunting,
7	fishing, or trapping" means travel, camping, scouting, target shooting, dog training,
8	animal baiting or feeding, or other acts that are preparatory to lawful hunting,
9	fishing, or trapping and that are done by a hunter, fisher, or trapper or by a member
10	of a hunting, fishing <u>,</u> or trapping party.
