Could you draft the following amendments to AB 561 (re: Managed Forestry Law changes) for us?

- 1). Remove the sections in 77.01(1)(b) and 77.86(1)(b) that list additional qualifications under which the department would be prohibited from prescribing the amount of forest products to be cut. Go back to current law (2015).
- 2). Delete the provision in 77.82(11) that requires departmental notification to all enrollees of changes in law and forces enrollees to choose between accepting changes or withdrawal from the program. Retain current law.
