This bill prohibits towns and counties from issuing, or expending funds for the issuance of (collectively, issues) a photo identification card (ID card) for any resident of the town or county, other than an employment—related identification card for employees of the town or county. Also under the bill, if a city or village issues an ID card, the card must state clearly on its face that the card is not authorized for voting purposes.

The bill also provides that an ID card issued by a city or village may not be used for voting, registration for voting, or to obtain public benefits, such as Wisconsin Works, including Wisconsin Shares; the food stamp program; the Medical Assistance program; and the programs that provide state supplemental payments to persons receiving federal supplemental security income.

The bill specifies that any card issued by a city, village, town, or county that had been used as an identification document for proof of residence for voting registration may no longer be used for that purpose.

Assumptions Used in Arriving at Fiscal Estimate

The Division of Family and Economic Security (DFES), within the Department of Children and Families, is responsible for determining the eligibility of program applicants as required in Chapter 49 of the Wisconsin statutes, administrative rule, and DCF policy. Among these eligibility requirements, applicants must provide verification of identity, birth date, Wisconsin residency, U.S. Citizenship or qualifying non-citizen status for all DFES-administered public assistance benefit programs, such as Wisconsin Works (W-2).

DFES programs are administered through contractors, grantees or local governments (agencies). Under current DFES policy, a list of the allowable types of verification documentation includes photo identification of the applicant that may be used by the agency to determine public assistance benefit eligibility. "Locally issued identification cards" are not explicitly included in this list. However, the list of suggested sources does allow the agencies to accept "any other reliable documentation" that verifies identity, birth date, or Wisconsin residency. Agencies can determine what sources of photo identification may qualify as "any other reliable documentation." For example, DFES program policy allows agencies to accept employee identification cards as a possible source to verify applicant identity.

Under this bill, DCF will be prohibited from using locally issued identification cards as verification of identity, birth date, or Wisconsin residency to determine non-financial eligibility requirements for public assistance benefits. Photo identifications issued by cities and villages or towns and counties would no longer be considered "other reliable documentation" as allowed in current DFES program policy.

By limiting the scope of acceptable documentation, some applicants who would otherwise be granted benefits may be unable to meet the eligibility requirements to obtain benefits. This may lead to a decrease in spending on benefits. However, it is difficult to say how many applicants currently provide locally issued identification as their form of identity verification because agencies do not enter the type of identification offered. In addition, if an applicant is denied W-2 or other benefits, then the applicant still may acquire sufficient documentation and reapply

Finally, not many, if any, cities, towns, villages, or counties provide the type of identification the bill refers to, though the City of Milwaukee and Milwaukee County recently introduced initiatives to develop a "locally issued ID" available to residents.

In regards to programs operated by the Division of Early Childhood Education, Wisconsin Shares does not currently accept identification issued by a village, town, city, or county as sufficient documentation of identity, and thus would not alter their operations to conform to this bill.

The fiscal impact of this bill would depend on the number of applicants who rely on locally issued identification to determine eligibility for public assistance programs and who reapply after a denial based on the locally issued identification. It is assumed that there would not be a large number of these applicants, and, therefore, any fiscal impact would be minimal.
