AN ACT to create 45.12 of the statutes; relating to: official logotypes for

Wisconsin veteran-owned businesses and disabled veteran-owned businesses.

Analysis by the Legislative Reference Bureau

This bill requires the Department of Veterans Affairs (DVA) to design an official "Wisconsin Veteran–Owned" logotype for use by businesses owned by Wisconsin veterans. The bill authorizes DVA to design an official "Wisconsin Disabled Veteran–Owned" logotype for use by businesses owned by Wisconsin veterans who are also disabled. Under the bill, DVA must consult with the Department of Administration in designing the official logotypes.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:
