Assumptions Used in Arriving at Fiscal Estimate

Assembly Bill 563 authorizes towns in a populous county to withdraw from county zoning and the county development plan. It would also require towns to enact a zoning ordinance, comprehensive plan and official map if they request to withdraw from the county zoning and its development plan.

Changes proposed under the bill may require counties and towns to incur costs for amendments to or the development of a zoning ordinance, comprehensive plan and official map. A county from which one or more towns withdraws from county planning and zoning would likely have decreased revenues that may not be commensurate with a reduction in costs associated with the withdrawal(s) and may impact the county's ability to sustain a planning department. A town that withdraws from county planning and zoning would likely have increased costs and revenues as a result of performing the planning and zoning functions. It is not possible to estimate the number of towns that may enact an ordinance withdrawing from coverage of a county zoning ordinance and a county development plan as permitted under the bill; therefore, the amounts associated with these changes are indeterminate.

Long-Range Fiscal Implications

Indeterminate
