Description Renewal of a certificate of food protection practices for certificate holders that operate or manage a restaurant employing five or fewer food handlers					

Assumptions Used in Arriving at Fiscal Estimate

Under current law, the Department of Health Services (DHS) issues certificates of food protection practices (FFP certificates) to individuals who complete an exam approved by DHS or who have achieved comparable compliance. The fee to receive FFP certification is \$10. The duration of certification is five years from the date of the examination.

This bill creates an exception to the FFP examination for certificate holders who operate or manage a restaurant employing five or fewer food handlers and wish to renew an FFP certificate. The bill requires that this subgroup of certificate holders be given the option to complete a recertification training course approved by DHS instead of an approved examination.

The creation of an exception under which an individual working in a restaurant will receive the option to complete a DHS approved course instead of an examination will require a separate food manager recertification process and tracking system as well as rulemaking to establish standards for recertification training courses. The Department will require a 0.5 FTE GPR Human Services Program Coordinator to develop criteria for training courses and promulgate rules. In addition, the position will confirm the number of employed food handlers at a restaurant and create/manage a separate tracking system for the optional completion of a course instead of an examination. In addition, this position would assist in the implementation of recertification course standards and monitor approved courses at each institution. The Department expects that this additional staff cost will come to \$36,400 per year, with a one-time cost of \$2500.

The Department does not anticipate a fiscal impact on local health departments.
