Assembly Amendment 1 to Assembly Amendment 4 to **Assembly Bill 212**

- 1. Page 1, line 4: delete the material beginning with "this" and ending with "act" on line 5 and substitute "the treatment of section 108.04 (11) (br) and (cr) of the statutes by this act".
- **2.** Page 1, line 8: delete "this act" and substitute "that treatment".
- **3.** Page 1, line 9: delete lines 9 to 11 and substitute: "2m. Page 1, line 13: delete the material beginning with that line and ending with page 2, line 2, and substitute:

"SECTION 3m. Effective dates. This act takes effect on the day after publication, except as follows:

(1c) The treatment of section 108.04 (11) (br) and (cr) of the statutes takes effect on the first Sunday of the 7th month beginning after publication, or on the

date specified in the notice under SECTION 3g (1m) of this act, whichever occurs first.".".
