fathers, mothers, aunts uncles, and cousins. They had families who loved them, who cared about them, who will never get a chance to say goodbye. Last spring, Senator Harris Dodd made a promise to each of you that she would stand up here most session days and adjourn in honor of lives lost to violence and she will keep standing up and speaking out until she gets every member of this body to join her in trying to save lives.
