AN ACT to repeal 118.045 and 118.38 (1) (a) 8.; and to amend 119.04 (1) of the statutes; relating to: the commencement of fall classes in public schools.

**Analysis by the Legislative Reference Bureau**

With certain exceptions, current law prohibits a school district from beginning fall classes until September 1. Beginning in the ~~2014-15~~ school year, this bill eliminates this prohibition.
