AN ACT to repeal 118.045 and 118.38 (1) (a) 8.; and to amend 119.04 (1) of the

statutes; relating to: the commencement of fall classes in public schools.

Analysis by the Legislative Reference Bureau

With certain exceptions, current law prohibits a school district from beginning fall classes until September 1. Beginning in the 2014–15 school year, this bill eliminates this prohibition.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:
