1 **AN ACT to amend** 446.028 of the statutes; **relating to:** continuing education
2 program sponsors for chiropractors, chiropractic technicians, and chiropractic
3 radiological technicians.

Analysis by the Legislative Reference Bureau

This bill requires that a program sponsor for continuing education for certified chiropractic technicians and certified chiropractic radiological technicians submit its program to the Chiropractic Examining Board for approval. The bill also adds the Chiropractic Society of Wisconsin, the American Chiropractic Association, and the Federation of Chiropractic Licensing Boards to the list of chiropractic continuing education program sponsors acceptable for license renewal in this state.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

4 **SECTION 1.** 446.028 of the statutes is amended to read:
5 **446.028 Continuing education approval; program sponsors.** Each
6 program sponsor of a continuing education program required to be completed by a

1 chiropractor, chiropractic technician, or chiropractic radiological technician as a
2 condition of license renewal shall submit the program to the examining board for
3 approval. In this section, “program sponsor” means the Wisconsin Chiropractic
4 Association, the Chiropractic Society of Wisconsin, the American Chiropractic
5 Association, the Federation of Chiropractic Licensing Boards, the International
6 Chiropractors Association, a college of chiropractic approved by the examining
7 board, and a college of medicine or osteopathy accredited by an accrediting body
8 listed as nationally recognized by the secretary of the federal department of
9 education. “Program sponsor” does not include an individual, organization, or
10 institution of higher education approved under s. 46.03 (38) to provide instruction
11 in the use of an automated external defibrillator.
