- 3 2. Page 3, line 2: delete that line. <sup>pe4</sup>
- 4 3. Page 3, line 4: delete lines 4 and 5. <sup>pe6 pe7</sup>
- 5 4. Page 3, line 20: delete the material beginning with that line and ending with
- 6 page 5, line 1, and substitute: <sup>pe4</sup>
- 7 "SECTION 20g. 440.63 (1) of the statutes is amended to read:
- 8 440.63 (1) ~~INSTRUCTOR CERTIFICATION REQUIRED~~ INSTRUCTORS. (a) No person may
- 9 provide practical instruction in barbering unless the person holds a current
- 10 ~~barbering instructor or cosmetology instructor certificate issued~~ barber license
- 11 granted by the department or cosmetologist license granted by the cosmetology
- 12 examining board.

1 (am) No person may provide practical instruction in cosmetology unless the  
2 person holds a current ~~cosmetology instructor certificate issued by the department~~  
3 cosmetologist license granted by the cosmetology examining board.

4 (b) No person may provide practical instruction in aesthetics unless the person  
5 holds a current ~~aesthetics instructor or cosmetology instructor certificate issued by~~  
6 ~~the department~~ aesthetician license or cosmetologist license granted by the  
7 cosmetology examining board.

8 (c) No person may provide practical instruction in electrology unless the person  
9 holds a current ~~electrology instructor certificate issued by the department~~  
10 electrologist license granted by the cosmetology examining board.

11 (d) No person may provide practical instruction in manicuring unless the  
12 person holds a current ~~manicuring instructor or cosmetology instructor certificate~~  
13 ~~issued by the department~~ manicurist license or cosmetologist license granted by the  
14 cosmetology examining board.

15 **SECTION 20r.** ✓ 440.63 (1m) of the statutes is created to read:

16 440.63 (1m) USE OF TITLE. (a) No person may use the title "Wisconsin certified  
17 barbering instructor," use any title that implies that he or she is a Wisconsin certified  
18 barbering instructor, or represent himself or herself to be a Wisconsin certified  
19 barbering instructor unless the person is certified as a barbering instructor under  
20 this subchapter.

21 (b) No person may use the title "Wisconsin certified cosmetology instructor,"  
22 use any title that implies that he or she is a Wisconsin certified cosmetology  
23 instructor, or represent himself or herself to be a Wisconsin certified cosmetology  
24 instructor unless the person is certified as a cosmetology instructor under this  
25 subchapter.

1 (c) No person may use the title “Wisconsin certified aesthetics instructor,” use  
2 any title that implies that he or she is a Wisconsin certified aesthetics instructor, or  
3 represent himself or herself to be a Wisconsin certified aesthetics instructor unless  
4 the person is certified as an aesthetics instructor under this subchapter.

5 (d) No person may use the title “Wisconsin certified electrology instructor,” use  
6 any title that implies that he or she is a Wisconsin certified electrology instructor, or  
7 represent himself or herself to be a Wisconsin certified electrology instructor unless  
8 the person is certified as an electrology instructor under this subchapter.

9 (e) No person may use the title “Wisconsin certified manicuring instructor,” use  
10 any title that implies that he or she is a Wisconsin certified manicuring instructor,  
11 or represent himself or herself to be a Wisconsin certified manicuring instructor  
12 unless the person is certified as a manicuring instructor under this subchapter.

13 **SECTION 26m.** <sup>✓</sup> 440.63 (2) of the statutes is amended to read:

14 440.63 (2) APPLICATIONS; ~~CERTIFICATION PERIOD.~~ An application for initial  
15 certification ~~or renewal or reinstatement~~ of a certificate under this section shall be  
16 submitted to the department on a form provided by the department. An application  
17 for ~~initial~~ certification shall include ~~the initial credential~~ a one-time certification fee  
18 determined by the department using the procedures established under s. 440.03 (9)

19 ~~(a). Renewal applications shall be submitted to the department on a form provided~~  
20 ~~by the department on or before the applicable renewal date specified under s. 440.08~~

21 ~~(2) (a) and shall include the applicable renewal fee determined by the department~~  
22 ~~under s. 440.03 (9) (a), and the applicable penalty for late renewal under s. 440.08~~

23 ~~(3) if the application is submitted late, except that no certification fee is required~~  
24 under this section for an individual who is eligible for the veterans fee waiver

1 program under s. 45.44. The department may not require renewal of a certificate  
2 issued under this section.”.
