Thanks for speaking with me about the communicable disease draft. As I mentioned, Aaron Whitaker from the fiscal bureau sent me some information related to the consolidated contract framework (see his email below).

Representative Tittl would like to remove lines 19-21 (LRB-2109/P1) and replace those lines with a provision (permitting? requiring? enabling?) DHS to determine the allocations within the consolidated contract framework. His intent is that DHS will be given some direction but will also have some discretion to determine the details.

In short, Representative Tittl wants to assure that the distribution of funds is fair, so that some counties do not improperly benefit while others are improperly harmed.

It is my understanding that the Hintz office will be sending you a request to release the draft to Representative Tittl. If I am not copied on that correspondence, please let me know when you receive it.

Following up from our conversation earlier, I looked into the methodology utilized by the department in allocating funding for programs under the consolidated contract framework. Here's a link to a document which explains the formulas used for several public health grant programs included in the consolidated contracts. The formulas use five factors, including a base allocation and a population weight. These specific formulas are not set in statute nor in rules promulgated by the department, but are determined by department policy. The statutes authorizing these programs tend to give the department discretion in determining an equitable distribution framework.

The following programs (excluding Public Health Preparedness) included in the Division of Public Health (DPH) consolidated contract (Childhood Lead Poisoning Prevention, Immunization, Maternal and Child Health, Preventive Health and Health Services Block Grant) use the following five factors in their allocation formulas:

- 1. Base Allocation (base amount or amount per local public health department by level)
- 2. General Population
- 3. Target Population(s)
- 4. Risk Factor(s)
- 5. Geographic Area (size of service area and/or density of population<sup>1</sup>)

Each program then assigns different weights (0%-100%) to each of these factors.

## 2017-19 BUDGET REQUEST - COMMUNICABLE DISEASE PREVENTION INITIATIVE

#### TOPIC:

Surveillance, investigation, control and prevention of communicable disease

#### REQUEST:


Create a continuing appropriation of \$2,500,000 per fiscal year (for a total of \$5,000,000 over the 2017-19 biennium) to control and prevent communicable disease in Wisconsin. The WI Department of Health Services shall distribute the funding to local health departments under a formula that would: 1.) Provide an identical base amount for every local health department; and 2.) Provide additional funding to local health departments that serve a population of more than 100,000 people. Local health departments shall utilize the funding for disease surveillance; contact tracing; staff development and training; improved communication with other health care professionals; public education and outreach; and other infection control measures required under state law.

#### RATIONALE:

The highest priority for public health in Wisconsin and across the country is efforts to prevent and control communicable disease, including traditional, ever present diseases, such as Tuberculosis, Hepatitis C, Influenza and Pneumonia, and emerging disease threats like Zika, Ebola, Middle East Respiratory Syndrome and other global diseases that require a local public health response. Supporting a robust public health infrastructure is critical in a globalized world that provides new opportunities for the emergence and spread of infectious disease. Unfortunately, Wisconsin currently has no dedicated, stable funding source for communicable disease control and prevention. As a result, local health departments are challenged with a lack of sufficient staff and resources, which are necessary to support effective infectious disease prevention efforts. These delays in basic follow-up and contact tracing investigations allow for opportunistic diseases to spread and become a crisis.

#### **DISCUSSION POINTS:**

- Wisconsin currently has no dedicated, stable funding source for communicable disease control and prevention efforts.
- While providing \$5 million in communicable disease funding in the next two-year budget cycle amounts to less than \$1 per capita, it will have a major impact, allowing local health departments statewide to improve disease surveillance, provide staff training, and develop public awareness plans.
- Supporting a strong public health infrastructure is paramount with the continuing occurrences of natural disasters, terrorist attacks and infectious diseases, such as tuberculosis, whooping cough, H1N1 influenza and Ebola.
- The challenges presented by infectious disease are more complex than they were even a decade ago.
   New microbes and mutated versions of old ones are being discovered regularly, creating real threats to the United States including Wisconsin in today's globalized world.
- Infectious disease control is one of the ten essential functions of public health, and with adequate funding, local health departments across Wisconsin will be better equipped and prepared to protect individuals, communities and the entire state from communicable disease threats.

## RESOLUTION TO SUPPORT SECURING STATE FUNDING FOR COMMUNICABLE DISEASE CONTROL FOR POPULATION HEALTH

WHEREAS, Wisconsin has no dedicated, stable federal and state funding sources for communicable disease control and prevention efforts despite over 20 state mandates requiring disease surveillance, investigation, prevention, and control; and

WHEREAS, a strong public health infrastructure is paramount to the health of all citizens; and

WHEREAS, increasing numbers of emerging and existing communicable diseases threaten health security, economies, and quality of life for all; and

WHEREAS, local health department communicable disease programs follow up on more than 70 communicable diseases to protect residents by responding to outbreaks, investigating communicable diseases, collecting data, and educating the community about prevention and the importance of immunizations; and

WHEREAS, local health departments have been successful in preventing the spread of communicable diseases through case reporting and involvement of public health staff in referral of exposed persons for screening and prevention services; and

WHEREAS, existing, emerging, and re-emerging, communicable diseases such as ebola, tuberculosis, influenza, SARS, measles, HIV/AIDS, syphilis, gonorrhea, rabies, hepatitis, and pertussis, can threaten the lives and well-being of Winnebago County and Wisconsin residents as well as personal and community safety and require substantial resources to contain; and

WHEREAS, bloodborne pathogens that cause long-term diseases such as Hepatitis C are occurring at unprecedented rates – rates that are accelerating as a result of the opiate epidemic; and

WHEREAS, evidence in the scientific literature indicates that partner notification services are not adequately assured in the absence of specific public health staff involvement; and

WHEREAS, local health departments and the State of Wisconsin have demonstrated commitment, competence and success in assuring the confidentiality of persons with reported communicable disease for decades, including cases of AIDS; and

WHEREAS, the Winnebago County Health Department along with other local health departments place a high priority on communicable disease control but could increase prevention efforts; and

WHEREAS, communicable disease control is one of the ten essential functions of public health; now, therefore, be it

**RESOLVED,** that the Winnebago County Board of Health urges the Wisconsin state legislature to develop and enact bipartisan support for funding of comprehensive, sustainable, effective and evidence based communicable disease control and prevention for the public's health; let it be

**FURTHER RESOLVED,** the Winnebago County Clerk is directed to forward a copy of this resolution to members of the Joint Finance Committee, Governor Scott Walker, Wisconsin Legislators representing Winnebago County, and the Wisconsin Counties Association.

By January 1, 2019, and biennially thereafter, each local health department is required to submit to the division at the department of health services that addresses public health issues a financial statement of its use of funds under this section.



communicable disease control and prevention funding.

## Analysis by the Legislative Reference Bureau

This bill requires the Department of Health Services to distribute funds to local health departments to use for communicable disease control and prevention measures, specifically, disease surveillance, contact tracing, staff development and training, improving communication among health care professionals, public education and outreach, and other infection control measures as required by law. Under the bill, DHS must take into consideration certain factors to establish an equitable allocation formula for the distribution of funds. The bill also requires each local health department to submit to DHS a financial statement regarding its use of funds received from DHS.
