Hi Nik

Right after I hung up with you, I found an old e-mail I had on this.

We would appreciate an amendment to SB 239 requiring services to update their operational plans they submit to DHS if they are going to utilize flexible staffing. Currently, services send us their operational plans per 256.12(2)(b). Our administrative rule (DHS 110.33(3)) also says providers must keep their operational plans up to date. We think this amendment would provide clarity to providers and will make it easier on us in that we'll be able to provide any technical assistance to services that wish to do this as we review their plans.
