Powerful special interest groups and wealthy corporations continue to have an overwhelming and growing effect on elections across Wisconsin and nationwide. Our neighbors feel their voices and our democracy are being drowned out by the constant flood of money into political campaigns. To answer this concern, I am

introducing a series of bills that address our most damaging campaign finance problems as identified by groups like the non-partisan Wisconsin Democracy Campaign.

This proposal will decrease the individual and candidate committee contribution limit from \$20,000 to \$10,000 for statewide candidates.

With a shrinking middle class, a sluggish economy, and greater cost of living, few Wisconsin families can afford to donate \$10,000, let alone \$20,000 to a campaign. Absurdly high donation limits diminishes the value of the smaller, affordable donations that our everyday Wisconsin neighbors can make. This bill is a big step toward eliminating special interest influence and empowering engaged voters.

Analysis by the Legislative Reference Bureau

This bill decreases the individual and candidate committee contribution limit from \$20,000 to \$10,000 for candidates for governor, lieutenant governor, secretary of state, state treasurer, attorney general, state superintendent, or justice.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

- SECTION 1. 11.1101 (1) (a) of the statutes is amended to read:
